- 7.1 The Committee received the report of the Executive Director of Assembly Secretariat as background to putting questions to the following invited guests:
 - Jazz Bhogal, Assistant Director of Health, Children and Young Londoners, Greater London Authority (GLA);
 - Dr Tom Coffey OBE, Mayoral Health Advisor;
 - Professor Kevin Fenton, Regional Director for London, Office of Health Improvement and Disparities, Regional Director of Public Health, NHS London, and Statutory Health Advisor to the GLA;
 - Vicky Hobart, GLA Group Director of Public Health & Deputy Statutory Health Advisor; and
 - Emma Pawson, Head of Health and Wellbeing / Programme Director for Free School Meals, GLA.

- 7.3 The Mayoral Health Advisor and the Statutory Health Advisor to the GLA gave short presentations to set the scene for the question and answers session using slides as attached at **Appendix 2**.
- 7.4 The Deputy Chair, the meeting guests and Health Committee Members thanked Dr Onkar Sahota AM as he prepared to stand down from the London Assembly, for his 12 years on the Health Committee including the nine years in the Chair.
- 7.5 The meeting adjourned at 3.58pm, reconvening at 4.05pm.
- 7.6 During the course of the discussion, the Mayoral Health Advisor agreed to provide the following additional information:
 - Whether London is on target to meet the World Health Organization target for air quality particulate matter less than 2.5 microns in diameter by 2030;
 - Whether the GLA Health team had a chance to have input into the Mayor of London's recent report on air quality;
 - Whether the Mayor has met his stretch target of lifting 75,000 more Londoners onto the Living Wage using the most up to date figures;
 - Whether there can be more campaigns on Transport for London regarding public health initiatives; and if so more detail on this;
 - The outcome of the consultation on maternity services in North Central London; or any response to the consultation from the GLA;
 - Who, within the GLA and within the Mayor's Office for Policing and Crime, is receiving updates on the work of the London Drugs Commission; and how much has been spent on that Commission;
 - How many survey responses were received from the London Drugs Commission consultation which ended on 7 July 2023;
 - The number of housing association projects that work with drug users who have their staff being trained to give out naloxone.
 - The Metropolitan Police Service (MPS) report regarding the data on number of incidents where the MPS are the first responder to an opiate overdose and how this impacted their view on officers carrying naloxone; and
 - The Home Office stance on London providing drugs testing services.
- 7.7 The Head of Health and Wellbeing, GLA, agreed to provide further examples of what the GLA Health Team have done to support Mental Health Champions.
- 7.8 The Assistant Director of Health, Children and Young Londoners, GLA, agreed to:
 - Share the evaluation of the School SuperZones programme; and
 - Confirm the number of School Superzones which have been implemented without a Controlled Parking Zone.

- 7.9 The GLA Group Director of Public Health agreed to:
 - Confirm whether there are interim targets on everyone in London getting their 20 minutes of physical activity by 2041; and
 - Confirm whether the Health team would lobby the Government to ask that the design of Copenhagen crossings can include a pedestrian priority sign as part of their implementation.
