1. Summary

1.1 This report presents an overview of the work and outputs of the Assembly Secretariat November 2022 -January 2023.

2. Recommendation

2.1 The Committee is recommended to note the Secretariat Quarterly Monitoring report for November 2022 to January 2023.

3. Scrutiny Activity

3.1 Committees have been proceeding with their planned work programmes, with some limited adaptations to reflect adjusted plans – for example, holding an additional informal meeting on Missing Children.

4. Assembly Committee Updates

Budget and Performance Committee

4.1 On 21 November, the Budget and Performance Committee wrote to the Mayor on his 2023-24 Budget guidance and Q1 2022-23 Greater London Authority (GLA) financial performance. The Budget and Performance Committee began its scrutiny of the Mayor's GLA Group budget proposals for 2023-24 at a Committee meeting on 22 November 2022 with GLA officers to discuss the 2023-24 Budget for the GLA Core. The Committee discussed the slow progress on delivering the Mayor's Green Bond Programme, the repair work required at the Crystal Palace National Sports Centre, and

that over the last six years the Mayor had received additional unanticipated income from business rates and council tax that averaged £198 million for each year. The Committee then met on 7 December 2022 to consider the 2023-24 Budget proposals for the mayoral development corporations and on 8 December 2022 to discuss the budget proposals for the Mayor's Office for Policing and Crime (MOPAC), the Metropolitan Police Service and the London Fire Commissioner.

4.2 On 4 January 2023 the Committee met with officers from Transport for London and the Deputy Mayor for Transport. This was followed by a meeting with the Mayor on 5 January 2023. On 13 January 2023 the Budget and Performance Committee published its response to the Mayor's 2023-24 Budget consultation. This highlighted that there was a significant growth in the reserves held by the GLA, despite planned reductions. The report asked the Mayor to reassess the GLA Group reserves position and establish a clear and consistent policy for the use of reserves across the GLA Group. On 18 January the Mayor published his Draft Consolidated Budget.

GLA Oversight Committee

- 4.3 On 9 November 2022 the GLA Oversight Committee considered the Mayor's £90 million investment in his Green Bond Programme, which aimed to deliver investment in green initiatives of £500 million. This meeting covered governance of the programme, and a meeting of the Environment Committee on 10 November 2022 considered the projects that would be delivered under the programme. On 14 December the Committee met to review the latest GLA's workforce report and to look at progress in delivering the 42 recommendations from the independent review by The Equal Group into whether there are structural barriers that prevent Black, Asian and Ethnic Minority staff progressing their careers at the GLA.
- 4.4 The GLA Oversight Committee met on 12 January 2023 to discuss the Mayor's Equality, Diversity and Inclusion Strategy and Annual Equality Reports. This was a Question and Answer session with the Deputy Mayor for Communities and Social Justice, Dr Debbie Weekes-Bernard. This was the rescheduled meeting from 13 September 2022, following the death of the Queen.
- 4.5 The Committee wrote to the Mayor on 30 January 2023 to request a response to a letter sent on 25 March 2022, following the Committee's Question and Answer sessions with Mayoral Advisors.

Transport Committee

- 4.6 The Transport Committee met on 15 November 2022 to look at Rail Reform and the Railways in London, with guests from the Rail, Maritime and Transport Workers Union (RMT), Great British Railways, London Travelwatch, and Transport for London (TfL). There was also a second section of the meeting examining London TravelWatch's 2023-24 Business Plan. On 14 December 2022, the Committee started a two-part investigation into Road User Charging, with panellists from BusinessLDN, Centre for London, Possible, Rebel Group, the Federation of Small Businesses, and the Campaign for Better Transport.
- 4.7 On 17 January the Transport Committee held a meeting on public transport fares in London. The Committee heard from the Deputy Mayor, TfL, Campaign for Better Transport, London TravelWatch and Age UK London and discussed the increase in fares for 2023-24, the impact this increase would have on passengers, the future of travel concessions and different fare structures. A letter to the Mayor is expected later this year.

Police and Crime Committee

- 4.8 On 2 November the Committee met with MOPAC to explore how MOPAC is faring ten years on from its creation and how effectively it delivers its functions. The Committee discussed the decision by His Majesty's Inspectorate of Constabulary, Fire and Rescue Services to place the Met into the Engage stage of monitoring and how MOPAC is ensuring local oversight of policing. The Committee also noted that MOPAC is failing to publish the minutes and papers from its various partnership boards.
- 4.9 On 30 November the Committee held the first of its meetings on its investigation into counterterrorism and radicalisation. The aims of the investigation are to assess the changing nature of terror, London's preparedness for a terrorist attack, and how agencies are countering radicalisation. The Committee met with Lord Toby Harris to explore the findings from his second Independent Review of London's Preparedness to Respond to a Major Terrorist Incident, published in March 2022, as well as Dr Shiraz Maher, Director, International Centre for the Study of Radicalisation, King's College London; Robin Simcox, Commissioner for the Commission for Countering Extremism; Charlotte Dixon-Sutcliffe MBE, Chairwoman, Survivors Against Terror; and Brendan Cox, Member, Survivors Against Terror to explore radicalisation and extremism in London.
- 4.10 On 16 November the Committee used its powers to summons the Mayor to a meeting, alongside Sir Tom Winsor, to explore the Mayor's actions in relation to the resignation of the former Metropolitan Police Commissioner, Dame Cressida Dick DBE QPM. Following this, the Chairman summonsed documents from the Mayor, in his capacity as the occupant of MOPAC, in order that the Committee could investigate further matters surrounding the resignation of the former Metropolitan Police Commissioner. The Committee again summonsed the Mayor to a further meeting on 13 December 2022.
- 4.11 On 11 January the Committee held the second meeting of its investigation into counter-terrorism and radicalisation. The Committee heard from the Metropolitan Police Service (the Met), Mayor's Office for Policing and Crime (MOPAC) and London Fire Brigade. It also requested written evidence from the London Ambulance Service and Her Majesty's Prison and Probation Service (which was received in February).
- 4.12 The Committee also continued its scrutiny of the Met and MOPAC through its monthly question and answer sessions. On 25 January, the Committee met with the Met Commissioner, Sir Mark Rowley QPM with two MOPAC representatives Diana Luchford, Chief Executive and Kenny Bowie, Director of Strategy and Met Oversight. The session was used to discuss the offending of David Carrick, the Commissioners' priorities of 'more trust, less crime, and high standards', the HMICFRS 'Engage' process, and reducing homicides in London.
- 4.13 In terms of outputs, the Committee sent a letter to the Mayor following its meeting with MOPAC in November 2022. The Committee recommended that MOPAC should provide quarterly updates to the Committee on how it is supporting the Met to address the failings identified by HMICFRS and to exit the Engage process and quarterly briefings detailing current issues it has flagged as part of its proactive oversight of the Met, and what action is underway to address them. It also published its *Probation Services in London* report on 20 January which made 13 recommendations largely directed at MOPAC and the London Probation Services. In February, the Committee received a response from the DMPC. The Committee also received responses from the Mayor and Independent Office for Police Conduct to its report on police conduct and complaints.

Fire, Resilience and Emergency Planning Committee (FREP)

- 4.14 The Committee had an informal meeting with the Deputy Mayor for Fire and Resilience and the London Fire Commissioner to discuss the Independent Culture Review on 12 January 2023 in advance of the formal meeting on 1 February 2023 which provided an opportunity for an open discussion on the findings of the review and how these were being addressed.
- 4.15 The Committee had a site visit on 18 January 2023 to the London Fire Brigade's Control Centre in Merton where it learned about the latest developments to deliver information to call handlers, including live video from police surveillance cameras being displayed on the big screen that shows the location of all live incidents and appliances. Members received presentations on Control's operation and from the London Resilience Group which has its local authority coordination centre co-located at Merton. Members were able to sit with call handlers and hear how live calls were dealt with. The visit added to the Committee's current investigation of London's Resilience and Emergency Planning.

Economy Committee

- 4.16 The Committee held a meeting on 30 November 2022 as part of an investigation into 'Winning the race to net zero for London's businesses'. The investigation aimed to explore the impact of unsustainable freight and congestion on businesses in London, and to identify the incentives and opportunities for businesses of making a modal shift to more sustainable freight, including cargo bikes and electric vans. At the meeting, the Committee questioned guests about the opportunities, risks and barriers for businesses using cargo bikes in London, as well as the Mayor's cargo bikes strategy, which is due to be published in 2023. Guests emphasised the benefits of cargo bikes, but also noted several areas where change is needed in order to scale up their use, in relation to infrastructure, regulation and public awareness.
- 4.17 The Economy Committee met on 18 January 2022 to discuss barriers to work for asylum seekers and refugees. In the first part of the meeting, the Committee heard from Breaking Barriers, Refugee Action, City of Sanctuary and a person with lived experience of being an asylum seeker and trying to work in the UK. In the second part they heard from two Deputy Mayors, Debbie Weekes-Bernard and Jules Pipe, who were questioned about GLA initiatives related to both skills and social inclusion which can reduce barriers to work for asylum seekers and refugees. The Committee asked questions about the legal barriers to asylum seekers accessing work, and the barriers to refugees continue to face in accessing work, including language and skills barriers.

Health Committee

4.18 The Committee held its final meeting of the calendar year on 24 November 2022, in order to scrutinise the new GLA Group Public Health Unit (PHU). This is a new Unit which was established earlier this year within the GLA and is designed to provide public health advice and support across the GLA Group. The Committee set out to understand what the purpose of the PHU is and how it is intended to strengthen London's public health system. It also asked what the PHU has achieved since it was established and what success would look like in twelve months' time. Guests included Dr Tom Coffey, the Mayor's Health Adviser, Vicky Hobart, the GLA Group Director of Public Health and Will Balakrishnan, Director of Commissioning and Partnership at MOPAC.

4.19 On 24 January 2023, the Health Committee visited London Ambulance Service's Newham Emergency Operations Centre and Dockside Education Centre. Members of the Committee were shown around the Education Centre, which is where paramedics are trained, and then had the opportunity to listen in on 999 calls in the Emergency Operations Centre. This was followed by a meeting at which the Committee put questions to London Ambulance Service staff about its new strategy. The Committee subsequently wrote to London Ambulance Service on 20 February 2023 with recommendations about how the new strategy could be strengthened.

Housing Committee

- 4.20 The Housing Committee held a two-part investigation into exempt supported accommodation. This included a call for evidence in October, informal roundtables on 22 November and a formal meeting on 6 December 2022. Guests included Tom Copley, Deputy Mayor for Housing and Residential Development; Bob Blackman, MP for Harrow East; and representatives from Crisis and Birmingham City Council. The Committee explored the provision of supported accommodation in London and assessed concerns with a particular part of the sector non-commissioned exempt supported accommodation.
- 4.21 The Housing Committee held an informal meeting on 5 January 2023 to discuss the topic of older people's housing in London. The Committee heard from the Centre for Ageing Better, Age UK, the International Longevity Centre, London Older Lesbian Co-housing, and the Race Equality Foundation.

Planning and Regeneration Committee

- 4.23 In November 2022, the Committee met to discuss the impact of the two Mayoral Development Corporations that exist in London Old Oak and Park Royal Development Corporation, and London Legacy Development Corporation. Representatives from both organisations attended, as well as representatives from community groups/those who have worked with communities, including the East End Trades Guild, OPDC community Review Group, and academics Tony Travers and Myfanwy Taylor.
- 4.24 On 17 Jan 2023 the Planning and Regeneration Committee published its report, 'the Future of Planning in London', which considered how the proposals in the Levelling Up and Regeneration Bill could affect London. The report featured 11 recommendations.

Environment Committee

4.25 In November 2022 the Environment Committee explored the GLA's Green Bond programme and Climate Budgeting with guests from the Connected Places Catapult, 3Ci, Climate Bonds Initiative, and GLA. On 7 December 2022, the Committee had panels on noise pollution in London and also light pollution. On 10 January 2023, the Environment Committee held a meeting on London's Environmental Priorities for 2023 which provided an opportunity for Assembly Members to engage with local environmental groups and campaigners. The discussion covered a range of issues, including tree planting, biodiversity, environmental messaging and air pollution.

1. Summary

1.1 This report presents an overview of the work and outputs of the Assembly Secretariat in February - April 2023, the last three months of the Assembly year. Overall, the period has seen a high level of activity by committees, including an increase in published outputs during the last month of the Assembly year.

2. Recommendation

2.1 The Committee is recommended to note the Secretariat Quarterly Monitoring report for February to April 2023.

3. Scrutiny Activity

3.1 Resourcing has remained a challenge through this period, but two additional staff members have joined, one at Policy Adviser level and one at Senior Policy Adviser (SPA) level. The latter takes up the long-awaited Transport and Environment SPA role but will initially cover only the Environment portfolio from February -April 2023, taking on the full joint portfolio from May 2023. In the meantime, a temporary cover for Transport SPA has been provided by an Acting Up role within the team.

4. Assembly Committee Updates

Budget and Performance Committee

- 4.1 The Budget and Performance Committee continued its scrutiny of the Mayor's Greater London Authority's (GLA) Group budget proposals for 2023-24. On 15 February the Mayor published his Final Draft Consolidated Budget. Together with the January 2023 Draft Consolidated Budget, these versions included an additional £317 million of expenditure and an extra £81 million in fares income when compared to the Mayor's Consultation Budget.
- 4.2 In an additional stage compared with the previous year's practice, these additions were considered at a further Budget and Performance Committee meeting on 21 February 2023 with the Mayor. The Mayor initially declined requests to be present at this meeting and was summonsed to attend. This meeting preceded the all-Assembly Budget Mayor's Question Time on 23 February 2023, at which the Mayor's Final Draft Consolidated Budget was considered by the London Assembly. The Mayor was questioned at the Budget and Performance Committee about his new Free School Meals for primary school children initiative, the Transport for London (TfL) fares increase from March 2023 and the budget implications of the Ultra Low Emission Zone (ULEZ) expansion.

GLA Oversight Committee

4.3 On 2 February 2023, the Committee met to discuss the London Recovery Programme and its impact to date. Guests for this meeting included London Recovery Board Members, GLA representatives and a London Councils representative. On 15 March 2023 the GLA Oversight Committee met with GLA Officers to examine the impact of the City Hall relocation on staff, London's democracy and the Royal Docks area and to assess the extent to which the relocation of City Hall has been a success, one year since the building opened to staff and Assembly Members.

Transport Committee

- 4.4 Following its first meeting of its investigation into the future of smarter road user charging in December 2022, the Committee held its second meeting in February 2023. The meeting looked at a number of practical questions around smarter road user charging and heard from TfL, London TravelWatch, Transport for West Midlands and the RAC Foundation. The Committee also published a call for evidence on this investigation, which closed on 10 March.
- 4.5 The final meeting of the Committee on 21 March was a Q&A with the Deputy Mayor for Transport and the Transport for London Commissioner. Topics covered in this meeting include Vision Zero, TfL finances, active travel investment, London's river crossings, the bus network in London, road user charging and rail in London.

Police and Crime Committee

4.6 The Committee continued its scrutiny of the Met and Mayor's Office for Policing and Crime (MOPAC) through its monthly question and answer sessions. In January, the Committee summonsed Diana Luchford, MOPAC's Chief Executive Officer, to attend the Committee's meeting on 22 February where it explored the Met's draft Turnaround Plan, Police recruitment and training, the Met's Safer Schools Officers and economic crime and money laundering.

- 4.7 On 8 February, the Committee held an informal meeting with the GLA Peer Outreach Team to hear evidence from young people for its missing children investigation. At the meeting, the Committee discussed with five Peer Outreach Workers and two Peer Outreach Team coordinators the causes of children going missing and how agencies including the Met, MOPAC and schools can prevent children from going missing. The Committee also received 18 written responses to its call for evidence, including 12 submissions from children safeguarding partnerships across London.
- 4.8 On 8 March, the Committee met with Baroness Casey following the publication of her Independent Review into the standards of behaviour and internal culture of the Met. Following this session, the Committee also met with the DMPC and Commissioner to discuss the Met's response to Baroness Casey's findings.
- 4.9 On 8 March, the Committee held a third meeting exploring counter-terrorism and radicalisation in London. It met with MOPAC and the Met's SO15 Counter Terrorism Command to explore the findings from the independent review of Prevent.
- 4.10 On 1 March, the Committee received an informal briefing on the Met's work to tackle fraud by Detective Superintendent John Roch, Head of Economic Crime, 12 months since the Committee concluded its investigation on online fraud.
- 4.11 In March the Committee responded to the Met's draft Turnaround Plan. The Committee welcomed the Plan and its commitment and action to address the urgent change needed across the Met. In April, the Committee published its report on missing children in London, making 17 recommendations to the Mayor, the Met and MOPAC. It also published its report on counterterrorism and radicalisation, making 12 recommendations.
- 4.12 On 6 April, the Committee visited the Met's Counter-Terrorism and Operations Centre.

Fire, Resilience and Emergency Planning Committee (FREP)

- 4.13 The Fire, Resilience and Emergency Planning Committee met on I February to discuss the Independent Culture Review of London Fire Brigade (LFB) which was published on 25 November 2022. The meeting was attended by Nazir Afzal OBE, former Chief Crown Prosecutor for the North West of England, who led the Culture Review, Baroness Twycross, Deputy Mayor for Fire and Resilience (DMFR), Andy Roe, London Fire Commissioner (LFC), and Tim Powell, Head of People, LFB. There was an in-depth discussion of the experience of Nazir Afzal in undertaking the review its findings and recommendations. The Committee heard about actions already taken to address the recommendations and work planned by the LFC. The LFC and DMFR provided assurance to the Committee that this work was being prioritised by them, but they acknowledged that achieving culture change across LFB would take time to deliver.
- 4.14 The Committee also considered LFB's national framework documents in its meeting on 1 February. The Committee is required under the GLA Act 1999 (as amended) to provide a report to the Mayor on these before they can be published. The Committee wrote to the Mayor on 3 February on LFB's Reserves Strategy and Medium-term Financial Strategy commenting that it noted LFB's intention to stabilise its reserves over the next two years. The Committee also wrote to the Mayor on LFB's Statement of Assurance commenting that it sought ongoing assurance that LFB is delivering on its Community Risk Management Plan and the recommendations remaining from the Grenfell Tower

Phase 1 report, the recommendations from His Majesty's Inspectorate of Constabulary, Fire and Rescue Services and those from the Independent Culture Review of LFB.

Economy Committee

- 4.15 The Committee met on 22 February to discuss barriers to work for people who have had contact with the criminal justice system. The Committee set out to understand why people with convictions often struggle to access employment, both upon release from prison and in the long term, and what action can be taken to address this by employers and public bodies. The Committee heard from MOPAC, Timpson Group, Unlock, Working Chance and New Futures Network about what action can be taken to reduce barriers to employment for people with convictions, including by the Mayor.
- 4.16 The Committee held its final meeting of the year on 15 March 2023, which focused on the financial security and employment opportunities of older Londoners. It considered the barriers to employment and economic activity amongst older Londoners, and what the Mayor is doing to support older Londoners into employment. The meeting was attended by guests from the London Borough of Hackney, the Centre for Ageing Better, Wise Age and Age UK London, as well as the GLA's Chief Digital Officer.
- 4.17 The Economy Committee published a series of outputs during this period. The Committee published letters to the Mayor on the Adult Education Budget, barriers to work for asylum seekers and refugees, barriers to work for people who have had contact with the criminal justice system, and older Londoners. It also published reports into 'culture off the beaten track', cargo bikes and food insecurity.

Health Committee

- 4.18 The Committee wrote to London Ambulance Service on 20 February 2023 with recommendations about how the new strategy could be strengthened.
- 4.19 On 28 February 2023, as part of its investigation into 'Healthy Living', the Health Committee took part in a cycle ride led by Cycle Sisters in Valentine's Park in Richmond. Cycle Sisters are a charity that runs cycling groups across London for Muslim women. Members were able to ride bikes with the rest of the group and heard about the physical and mental benefits of participating in Cycle Sisters groups. The site visit was covered by the Evening Standard and London Live.
- 4.20 On 2 March 2023, the Committee held a meeting in City Hall on healthy eating habits, which was also part of the 'Healthy Living' investigation. The Committee heard from representatives of three community organisations, Eat Club, Highams Park Food Aid and London's Community Kitchen, as well as a public health nutritionist and GLA representatives. The Committee set out to understand what the barriers are to Londoners eating healthily, and scrutinised the Mayor's initiatives to improve healthy eating, including the TfL junk food advertising ban and free school meals.
- 4.21 The Health Committee published three outputs during this period: letters to the Mayor on the GLA Group Public Health Unit and London Ambulance Service, and a report on maternal health and care.

Housing Committee

- 4.22 On 1 Feb 2023 the Housing Committee held a formal meeting on the topic of resident voice in social housing, considering how this has changed since the disaster at Grenfell in 2017. The Committee heard from a range of voices across two panels. The first panel included Tom Copley, Deputy Mayor for Housing and Residential Development, and representatives from One Housing, Islington Council, and the Chartered Institute of Housing. The second panel consisted of housing campaigners Kwajo Tweneboa, Sam Vacciana from Southwark Group of Tenants Organisations, Pat Turnbull from the London Tenants Federation and Khalid Mair from Imani Housing Co-op and BME London Landlords tenants' forum.
- 4.23 As a result of this investigation on resident voice in social housing, the Committee wrote a letter to the Mayor in April 2023. The letter urged the GLA to establish a Social Housing Commissioner for London, to ensure tenant's rights and interests are at the forefront of housing in London.
- 4.24 On 21 February 2023 the Housing Committee published its report 'Women and housing: a gap in the market', which was reported on by Inside Housing, the BBC and the Standard. The report featured 13 recommendations to improve access to safe, secure and affordable housing for women in London.
- 4.25 On 1 March the Housing Committee held an informal session, hosting three different stakeholders who had approached the Committee for a meeting over the course of the year. The Committee heard from the Smith Institute about social housing allocations; the New Horizons Youth Centre about youth homelessness in London; and the Women's Development Unit about women experiencing rough sleeping and multiple disadvantages.
- 4.26 On 20 March, the Housing Committee published its report entitled 'Exempt supported accommodation: Unsafe and Unsupported'. Key findings included instances of poor-quality and unsafe exempt accommodation. The report included 19 recommendations to the GLA on how to tackle problems with exempt accommodation in London, and it was accompanied by a launch event in Parliament.

Planning and Regeneration Committee

- 4.27 On 1 March 2023, the Committee published a letter outlining proposed amendments to the Levelling Up and Regeneration Bill. The amendments aligned with the recommendations set out in the Committee's report on 'the Future of Planning in London' which was published in January 2023.
- 4.28 Also on 1 March 2023, the Committee held a meeting on the topic of planning and the climate emergency, considering in detail the topic of Whole Life Carbon assessments. The Committee heard from the GLA, AECOM, the Chartered Institution of Building Services Engineers, and Hawkins\Brown, whose speaker was also a Mayoral Design Advocate. A second meeting on the topic was held on 22 March 2023.

Environment Committee

4.29 On 1 February, the Committee published its *London Under Water* report into Flooding which outlined the steps the Mayor should take to reduce the risk of flooding and increase London's preparedness for flooding. It included recommendations to bring together key stakeholders annually

- to re-assess preparedness, expand communications, and actions to retain and increase green space to prevent flooding.
- 4.30 On 7 February, the Environment Committee held a meeting which explored the impacts of light and noise on Londoners and the natural environment. The session was split into two panels, the first of which focused on noise and included two representatives from Heathrow airport. City Airport was also invited but did not attend. The second session heard from experts on light, including representatives from the Royal Astronomical Society, Buglife, Enfield Council and a Dark Sky Consultant and Volunteer for Campaign to Protect Rural England (CPRE). It considered whether existing policies were sufficient to prevent increased light pollution.
- 4.31 The Environment Committee's session on 9 March was a meeting with the Deputy Mayor on Environment and Energy to find out progress on the Mayor's Environment Strategy and the scale of interventions needed to achieve net zero by 2030, including the environmental impacts of emissions zones. The Committee also wrote to London City Airport expressing serious concerns over their proposed expansion in March 2023.

5 Legal Implications
