1 Apologies for Absence and Chair's Announcements (Item 1)

- 1.1 Apologies for absence were received on behalf of Valerie Shawcross CBE AM.
- 1.2 The Chair welcomed to the public gallery guests from the Oregon Students Abroad Programme and the Richmond Park Forum.

2 Declarations of Interests (Item 2)

2.1 The Assembly received the report of the Executive Directof of Secretariat.

2.2 **Resolved:**

- (a) That the list of offices held by Assembly Members, as set out in the table at Agenda Item 2, be noted as disclosable pecuniary interests; and
- (b) That Roger Evans AM's declaration of a non-pecuniary interest, arising from his appointment as a member of the European Committee of the Regions, be additionally noted, insofar as it related to the business set out on the agenda for the meeting.

3 Minutes (Item 3)

3.1 **Resolved:**

That the minutes from the London Assembly (Plenary) meeting held on 27 January 2016 be signed by the Chair as a correct record.

4 Final Draft Consolidated Budget 2016/17 (Item 4)

Report of the Mayor (Item 4a)

- 4.1 The Assembly received the Mayor's Final Draft Consolidated Budget 2016/17 for the GLA Group.
- 4.2 The Chair also explained that, in accordance with section 100(B)(4) of the Local Government Act 1972, she had agreed to admit to the agenda as urgent business some correspondence between the Clerk to the London Fire and Emergency Planning Authority (LFEPA) and the Mayor's Chief of Staff in relation to LFEPA's component budget for 2016/17. This correspondence had been circulated and published under cover of a supplementary agenda for

the meeting. The Chair had agreed to admit this correspondence on the basis that the letters had not been issued until after the publication of the main agenda for the meeting and by way of background information to the Assembly's consideration of the Final Draft Consolidated Budget 2016/17.

4.3 Resolved:

That the letter from the Clerk of the London Fire and Emergency Planning Authority to the Mayor's Chief of Staff dated 17 February 2016 and the response from the Chief of Staff dated 18 February 2016 be noted.

- 4.4 The Assembly then received an oral statement from the Mayor on the Budget. A transcript of the Mayor's oral statement is attached as **Appendix 1**.
- 4.5 Sir Edward Lister, Chief of Staff and Deputy Mayor for Policy and Planning, and Martin Clarke, Executive Director of Resources, were also in attendance for the statement and for the duration of the question and answer session.

Questions to the Mayor (Item 4b)

4.6 Assembly Members put questions to the Mayor on his Final Draft Consolidated Budget. The transcript of the questions put by Members and the Mayor's answers is attached as **Appendix 2**.

Consideration by the Assembly of the Mayor of London's Final Draft Consolidated Budget Proposals 2016/17 (Item 4c)

- 4.7 Following the Mayor's departure, the Assembly debated the Mayor's Final Draft Consolidated Budget 2016/17.
- 4.8 The substantive motion before the Assembly was: "To approve the Final Draft Consolidated Budget for 2016/17 with or without amendment."
- 4.9 A Formal Budget Amendment, presented on behalf of the London Assembly's GLA Conservatives Group, was moved by Gareth Bacon AM and seconded by Kemi Badenoch AM (and is attached as **Appendix 3**).
- 4.10 A Formal Budget Amendment, presented on behalf of the London Assembly's Liberal Democrat Group, was moved by Stephen Knight AM and seconded by Caroline Pidgeon MBE AM (and is attached as **Appendix 4**).
- 4.11 A Formal Budget Amendment, presented on behalf of the London Assembly's Green Party Group, was moved by Darren Johnson AM and seconded by Jenny Jones AM (and is attached as **Appendix 5**).

- 4.12 In accordance with Standing Order 6.6E(1), a named vote was taken on each Budget Amendment, in the order in which they were moved.
- 4.13 The votes in relation to the Budget Amendment in the name of Gareth Bacon AM were cast as follows:

- 4.18 With 2 votes being cast in favour and 22 votes being cast against, the Budget Amendment did not receive the requisite two-thirds majority to amend the Mayor's budget proposals.
- 4.19 Stephen Knight AM moved and Caroline Pidgeon AM seconded a Budget Related Motion (attached as **Appendix 6**).
- 4.20 Upon being put to the vote, the motion was lost (4 votes cast in favour and 20 votes cast against).
- 4.21 Len Duvall AM moved and Dr Onkar Sahota AM seconded a Budget Related Motion (attached as **Appendix 7**).
- 4.22 Upon being put to the vote, the motion was lost (11 votes cast in favour and 13 votes cast against).
- 4.23 The Chair then formally put the substantive motion, namely,
 - "To approve the Final Draft Consolidated Budget 2016/17 without amendment"
- 4.24 At the request of Gareth Bacon AM and in accordance with Standing Order 2.7, a named vote was taken and the votes were cast as follows:

- 4.25 With 9 votes being cast in favour and 15 votes being cast against, the motion was lost. The Chair explained that, although the substantive motion had not been agreed, as no amendments to the Budget had been agreed by the requisite majority, and in accordance with Paragraph 8(5) of Schedule 6 to the GLA Act 1999 (as amended), the Assembly was deemed to have approved, without amendment, the Final Draft Consolidated Budget for 2016/17.
- 4.26 The Chair confirmed that that concluded the Assembly's consideration of the Final Draft Consolidated Budget for 2016/17.

4.27 During the course of the discussion on this Agenda Item and in response to a query raised, the Chair confirmed that the Chair and officers would use the mode of address/title for each Member in line with individual Member's requests in this regard.

5 Mayor's Report (Item 5)

5.1 **Resolved:**

That the Mayor's report covering the period from 7 January to 8 February 2016 be noted.

7 Date of Next Meeting (Item 7)

7.1 It was noted that the next scheduled meeting of the London Assembly would be the Plenary meeting which would take place at 10.00am on Wednesday 2 March 2016 in the Chamber, City Hall.

8 Any Other Business the Chair Considers Urgent (Item 8)

Urgent Motion (Item 8b)

- 8.1 The Chair explained that, in accordance with section 100(B)(4) of the Local Government Act 1972, she had agreed to admit to the agenda as an item of urgent business a motion in the name of Len Duvall AM, in order that the matter could be dealt with at the earliest opportunity. The wording of the motion had been circulated under cover of a supplementary agenda for the meeting.
- 8.2 In accordance with the provisions of Standing Order 3.12, Len Duvall AM, as proposer of the motion, was permitted one minute to explain to the Assembly why it should agree to consider the motion.
- 8.3 Upon a vote without debate, the Assembly agreed to treat the motion as urgent and consider it (14 votes cast in favour and 10 votes cast against).
- 8.4 In response to a point of order raised, the Chair confirmed that it was not procedurally improper for the Assembly to express a view in relation to membership of the European Union

prior to the June 2016 referendum on this matter and nor would this prohibit the Assembly, following the May 2016 GLA elections, in expressing additional or alternative views.

8.5 Len Duvall AM moved, and Stephen Knight AM seconded, the following motion:

"This Assembly notes the reforms negotiated by the Prime Minister as part of his drive for Britain to remain in a reformed European Union. This Assembly welcomes the Prime Minister's decision to campaign to remain in the EU. We believe that both London and the UK are better off in the EU.

The Assembly notes the following benefits to London of EU membership:

Economic Prosperity: In 2014 London exported £12.3 billion of goods to the EU (nearly 43% of all London's exports of goods) in the same year we imported £27.6 billion of products from the EU (40.4% of all the capitals imported goods). Meanwhile analysis conducted by the Centre for Economics and Business Research (CEBR) for London First says that EU membership could add £13.9bn to London's Economy by 2030 providing a "permanent boost" to the capital's economy.
