1. Apologies for Absence and Chair's Announcements (Item 1)

1.1 There were no apologies for absence.

2. Declarations of Interests (Item 2)

3.1 **Resolved:**

That the minutes of the London Assembly's (Mayor's Question Time) meeting held on 30 January 2013 be signed by the Chair as a correct record.

4. Final Draft Consolidated Budget 2013-14 (Item 4)

Report of the Mayor (Item 4a)

- 4.1 The Assembly received an oral statement from the Mayor on his Final Draft 2013-14 Consolidated Budget for the GLA Group. A transcript of the oral statement is attached as **Appendix 1**.
- 4.2 Sir Edward Lister, Chief of Staff and Deputy Mayor for Planning, and Martin Clarke, Executive Director of Resources, were also in attendance for this item.

Questions to the Mayor (Item 4b)

4.3 In accordance with Standing Order 4.5 and with the consent of the Chair, Valerie Shawcross AM moved, and Jenny Jones AM seconded, that the Assembly proceed to the next item of business on the agenda. Upon being put to the vote, this procedural motion was agreed (16 votes cast in favour and 8 votes cast against). As Item 4b was therefore not considered, the

Chair confirmed that the part of the meeting that required the Mayor's attendance was concluded.

Consideration by the Assembly of the Mayor of London's Final Draft Consolidated Budget Proposals 2013-14 (Item 4c)

- 4.4 Following the Mayor's departure, the Assembly debated the Mayor's Final Draft Consolidated Budget 2013-14.
- 4.5 The substantive motion before the Assembly was: "To approve the Final Draft Consolidated Budget for 2013-14 with or without amendment."
- 4.6 A formal budget amendment, presented on behalf of the London Assembly's Conservative Group, was moved by Gareth Bacon AM and seconded by Andrew Boff AM (and is attached as **Appendix 2**).
- 4.7 A formal budget amendment, presented on behalf of the London Assembly's Green Group, Liberal Democrat Group and Labour Group was moved by Jenny Jones AM and seconded by Caroline Pidgeon AM (and is attached as **Appendix 3**).
- 4.8 A formal budget amendment, presented on behalf of the London Assembly's Labour Group, Green Group and Liberal Democrat Group, was moved by John Biggs AM and seconded by Darren Johnson AM (and is attached as **Appendix 4**).
- 4.9 Following debate and in accordance with Standing Order 6.6E(1), a named vote was taken on each amendment.
- 4.10 Upon being put to the vote, the votes in respect of the amendment in the name of Gareth Bacon AM were cast as follows:

- 4.11 The amendment was declared lost, with 9 votes being cast in favour and 16 votes being cast against.

4.18 Stephen Knight AM moved and Nicky Gavron AM seconded the following budget-related motion:

"This Assembly notes:

- i) That 380,301 households or over 800,000 people are currently on London boroughs' housing waiting lists, with one in four children living in overcrowded homes;
- ii) That just 425 affordable homes were started, and 1,558 completed, across London in the 6-month period to September 2012; and

iii) That one in four families (25.8 per cent) are now renting privately across London, with the sector increasingly being used to meet the housing needs of vulnerable households.

This Assembly further recognises:

- i) That London's population is expected to grow by 1.5 million over the next 20 years, increasing the need for affordable homes across the capital; and
- ii) That average rents in London's private sector are expected to rise by over 50 per cent in the next ten years, such that by 2024 the average private rent in the capital will be over £500 per week.

This Assembly believes:

- i) That a large new affordable home-building programme would boost jobs and growth at the same time as addressing London's chronic shortage of affordable homes; and
- ii) That a more consistent standard of property management and maintenance is required if the private rented sector is to meet the needs of an increasingly diverse range of tenants.

This Assembly therefore calls on the Mayor:

- To use the new flexibilities over the distribution of Business Rates to release some of the on-going (and unforecast) surpluses generated by Transport for London (TfL) to meet the financing costs of building additional affordable homes across London;
- ii) To establish a 'Know your Rights' website for tenants;
- iii) To assist boroughs in using the full range of enforcement powers at their disposal to crack down on roque landlords operating in the private rented sector;
- iv) To investigate the feasibility of creating a London-wide public lettings agency; and
- v) To examine the affordability of London rents and explore potential mechanisms for stabilising rent increases."
- 4.19 Upon being put to the vote, the budget related motion in the name of Stephen Knight AM, namely:

"This Assembly notes:

- That 380,301 households or over 800,000 people are currently on London boroughs' housing waiting lists, with one in four children living in overcrowded homes;
- ii) That just 425 affordable homes were started, and 1,558 completed, across London in the 6-month period to September 2012; and
- iii) That one in four families (25.8 per cent) are now renting privately across London, with the sector increasingly being used to meet the housing needs of vulnerable households.

This Assembly further recognises:

- i) That London's population is expected to grow by 1.5 million over the next 20 years, increasing the need for affordable homes across the capital; and

- iv) To investigate the feasibility of creating a London-wide public lettings agency; and
- v) To examine the affordability of London rents and explore potential mechanisms for stabilising rent increases."

was agreed (16 votes cast in favour and 9 votes cast against).

4.20 There being no other formal budget amendments or budget-related motions, the substantive motion, namely:

"To approve the Final Draft Budget 2013-14 without amendment."

was put to the vote.

4.21 There being 9 votes cast in favour and 16 votes cast against, the substantive motion was not agreed.

- 4.22 The Chair explained that, as no amendments to the Budget had been agreed by the requisite majority, in accordance with Paragraph 8(5) of Schedule 6 to the GLA Act 1999 (as amended), the Assembly was deemed to have approved, without amendment, the Final Draft Consolidated Budget for 2013-14.
- 4.23 The Chair announced that this concluded the Assembly's consideration of the Final Draft Consolidated Budget for 2013-14.

5. Mayor's Report (Item 5)

5.1 **Resolved:**

That the Mayor's Report covering the period from 17 January to 11 February 2013 be noted.
