Consultation on the proposed relocation of City Hall to The Crystal

This letter comprises an initial submission by the London Assembly in response to your consultation exercise on the proposed relocation of City Hall to The Crystal.

This is not the full Assembly response. Our full response will be provided by the end of the extended deadline, subject to the response we receive to this initial submission.

We are grateful for the extension to the deadline for our response although I have to say that Members were surprised that not everyone was afforded this additional time. That does not seem proper or fair to us, given that a lot of important information, including the results of staff surveys, is not yet available.

I should emphasise also that this submission is based on a strong consensus across all party groups on the London Assembly.

The London Assembly fully understands the scale of the financial challenges facing London and London government. We will play a full part in finding solutions to these problems.

As such, and noting the Chief Officer's stated commitment to looking at alternatives, I write to ask you immediately to work with the Assembly in commissioning and undertaking an assessment of the option of locating the London Assembly and Secretariat on the first floor of the LFC's Union Street headquarters (at 169 Union Street, Southwark).

We are dismayed that no other options than the move to Crystal have been put forward to date for our consideration, when clearly there are a number that exist that may offer cost-effective and viable alternatives. On behalf of the Assembly, I wish to register serious concern that the fact that an entire floor of an existing building within the GLA Group is apparently available for a new tenant was not included as an option with your consultation proposals. This appears to be an extraordinary omission. Had this option been made known to you and your team, for example through the Collaboration Board's work on estates? If it was known that this option existed, we will obviously be asking further questions.

Either way, Union Street is a building already leased and used by the GLA Group, it has meeting room facilities (and indeed it was used for many years for formal meetings of LFEPA), it is close to Palestra, close to major transport hubs and is centrally located. If the length of its lease or the cost of its space were prohibitive issues, then continued use of its space by the GLA would presumably have been ended as part of the current proposals to make savings through changes to the GLA's accommodation. As leaving Union Street is not proposed, we must assume that it is a viable option.

The Assembly, through its Executive Director, expects to be fully involved in urgent work to assess the potential use of the first floor of the Union Street building by the London Assembly and its Secretariat from late 2021 onwards. We also expect to then be able to review the detailed assessment of the Union Street option.

We request that an initial assessment is provided well before Friday 14 August, in order that it can inform our full response to the consultation.

Please be advised that we are in the process of considering other alternative proposals. This is because there are serious concerns within the Assembly regarding the viability of the proposal for use of The Crystal for its operations.

We understand the pressures of time arising from the presentation of alternative options, and we are bringing forward the option of using the first floor at Union Street now in order not to cause unnecessary delay. However, it appears to be the case that proper engagement with the London Assembly on the issue of its own accommodation before now would have elicited a range of potential options earlier. This would have avoided any issues that may now arise as a direct result of not working in partnership with us from the start.

Finally, we would also like a full update on progress in the discussions with the landlord of City Hall, St Martins, well before Friday 14 August.

We further request that:

- (a) the option of continued use by the London Assembly of the Chamber and meeting rooms at City Hall following any exit by the GLA from the building is put forward immediately, as part of those discussions, with a view to establishing whether that is a possibility, regardless of where the Assembly's office space is then located; and
- (b) the Landlord is asked to confirm the charges they would levy, including details of any months where rent would not be charged and any changes to the current fees and charges, for the continued use of City Hall by the GLA for the period January 2022-December 2026.

Update on these two matters should be included within the progress update given latest by 14 August, as requested above.
