# Title: Confirmation Hearing for Deputy Chair of Transport for London

### 1. Executive Summary

- 1.1 In accordance with the Assembly's Standing Orders and the provisions of Schedule 4A to the GLA Act 1999 (as amended), the Chair of the Assembly has delegated authority to: (i) decide whether to hold a confirmation hearing for the Mayor's candidate for appointment to the officed listed in Section 60A(3) of the Act; and (ii) to request that the Mayor's candidate for appointment produce, under paragraph 6(4) of Schedule 4A of the GLA Act 1999 (as amended), documents that relate to his or her proposed appointment.
- 1.2 The Chair of the London Assembly received a letter from the Mayor on 11 May 2021 indicating his intention to appoint Heidi Alexander to the office of Deputy Chair of Transport for London. A copy of the letter from the Mayor is attached at **Appendix 1**.
- 1.3 Following receipt of the letter and informal consultation with party Group Leaders, the Chair of the London Assembly decided to hold a confirmation hearing in relation to the Mayor's proposed appointment to the office of Deputy Chair of Transport for London, and to ask the candidate to provide a CV and supporting statement. Copies of the Chair's letters to the Mayor and Heidi Alexander are attached at **Appendices 2 and 3**.

#### 2. Decision

- 3.1 That the Chair of the London Assembly agreed to:
  - (a) Hold a confirmation hearing in relation to the Mayor's proposed appointment of Heidi Alexander to the office of Deputy Chair of Transport for London; and
  - (b) Ask the candidate to provide a CV and supporting statement.
