# Title: Extension to the term of appointment of the Chair of London TravelWatch

## 1. Executive Summary

- 1.1 At the Transport Committee meeting on 13 September 2021 the Committee resolved:
  - 7.2 (b) That authority be delegated to the Chair, in consultation with the Deputy Chairman and party Group Lead Members, to agree the extension of the appointment of the Chair of the London TravelWatch Board.
- 1.2 Following consultation with party Group Lead Members, the Chair agreed that the term of appointment for the Chair of the London TravelWatch Board, Arthur Leathley, should be extended by two years until 30 September 2023 in order to assist with succession planning on the Board of London TravelWatch, and on the basis of his excellent work during a challenging period.
