1. Executive Summary

- 1.1 In accordance with the Assembly's Standing Orders and the provisions of Schedule 4A to the GLA Act 1999 (as amended), the Chair of the Assembly has delegated authority to: (i) decide whether to hold a confirmation hearing for the Mayor's candidate for appointment to the officed listed in Section 60A(3) of the Act; and (ii) to request that the Mayor's candidate for appointment produce, under paragraph 6(4) of Schedule 4A of the GLA Act 1999 (as amended), documents that relate to his or her proposed appointment.
- 1.2 The Chair of the London Assembly received a letter from the Mayor on 13 October 2021 indicating his intention to appoint Liz Peace CBE to the office of Chair of Old Oak and Park Royal Development Corporation (OPDC). A copy of the letter from the Mayor is attached at **Appendix 1**.
- 1.3 Following receipt of the letter and informal consultation with party Group Leaders, the Chair of the London Assembly has decided to hold a confirmation hearing in relation to this proposed appointment to the office of Chair of OPDC, and to ask the candidate to provide a CV and supporting statement. Reappointment - Chair of Old Oak and Park Royal Development Corporation (OPDC)

I write to give notice to the London Assembly of my intention to reappoint Liz Peace CBE as Chair of OPDC, when her current term ends on 30 November 2021.

I propose to reappoint Liz Peace up to November 2024 to ensure first and foremost that OPDC benefits from continuity of leadership. Liz has been the Chair of the Board since 2017, during which time she has steered the organisation through some difficult challenges. The corporation is now at a critical juncture, with a revised regeneration strategy and Local Plan modifications due to be considered by the Planning Inspector in the coming weeks, and engagement with government over land and funding reaching a key stage shortly. A change in leadership at this point would risk destabilising these critical engagements. Liz has also established an excellent working relationship with David Lunts and his senior team, which I am keen should not be disrupted.

Liz has first-class networks across government, industry, OPDC's local boroughs and other stakeholders, following a long and very successful career in the civil service, property and regeneration, including 13 years as Chief Executive of the British Property Federation. Her profile, senior contacts and influence are an important asset for OPDC and a change of leadership at this point would undermine the confidence of the project with external partners and influencers.

It is clear that Liz enjoys the confidence of her Board members and has proved a highly effective and facilitative chair, with a strong working relationship with me and my team, as well as a wide range of external stakeholders.

Finally, there is more work to do to achieve greater diversity across senior positions in the property and planning sectors. For too long, it has been male-dominated and far from representative of our city. Liz is committed to ensuring that this should change, and be an exemplar for other women, a role she has taken to heart as a mentor and sponsor on my 'OurTime' programme.
