# Question and Answer Session with the Mayor's Office for Policing and Crime and the Metropolitan Police Service (Item 5)

  - Provide further information on the pilot scheme in Lambeth and Southwark where women were joining police officers on patrol to share their concerns about safety;
  - Provide further information on the number of domestic violence protection orders; and
  - Provide further information on the 48 actions included in the implementation plan for domestic violence cases.

  - Arrange a briefing for Committee Members on how MOPAC evaluates the impact and value for money of the projects and programmes it invests in;

  - Provide further information on the work MOPAC has done to review how hate crime offenders in London are dealt with.
