Welcome and Actions

Continuity of Care

The Office for Health Improvement and Disparities' (OHID) Head of Alcohol, Drugs and Tobacco (London) presented to members on the current continuity of care position and provided an update following the recent London conference on the topic. The key challenges and recommended steps to take to meet the Government's targets were outlined, and areas where partners could provide support were identified.

<u>Housing</u>

Representatives from the MPS, local authorities, GLA Housing and OHID Housing spoke to partners about the various barriers in terms of housing for those exiting prison and entering into substance misuse treatment. Co-chairs agreed that the topic should be returned to future meetings to cover further challenges relating to housing.
