#### Public interest assessment

At present, on balance, it is considered that the public interest is best served if the information is not disclosed at this point. Disclosure by the LFC would be likely to have a detrimental effect on the LFC's position and related commercial interest regarding the expenditure incurred on the procurement of the new support contract for security and licensing up to five years from February 2022.

The eligibility of these exemptions should be reassessed in the event of an FOI request for this information as the level of sensitivity will change over time and different circumstances may alter the arguments in favour of non-disclosure.

Introduction and background

Part 1 of DMFD141 sets out the proposal for the Deputy Mayor for Fire and Resilience to authorise the LFC to commit revenue expenditure of expenditure to procure a new support contract for network security and licensing for up to five years from February 2022.

The amount of expenditure required to be authorised is £450,000.

At £82,043 per year, the cost of a five-year contract will be £410,215.

As part of the current ICT environment, the above sums are included in the current approved revenue budgets. The approval sought includes a contingency sum of £39,785 over the life of the contract to allow for fluctuations in exchange rates and potential changes to the security architecture arising from organisational change. This sum can also be met from existing revenue budgets.

### **Financial comments**

The report recommends that revenue expenditure of up to £450,000, including an approximate 10 per cent contingency, is agreed to procure a new support contract for network security and licensing for up to five years from February 2022. The cost of this will be met from within existing ICT department budgets.
