



# Approval of Extension of Contract for External Legal Support for Public Inquiry Team.

#### **EXECUTIVE SUMMARY**

The Designated Lawyer Team is a core participant in the Undercover Policing Inquiry. It represents over 100 police officers called as witnesses to give evidence in the Inquiry. Due to the demand on the services provided by the Directorate of Legal Services to the whole of the MPS, it was not feasible to continually extract lawyers and administrative staff from DLS to staff the Designated Lawyer Team. Consequently, a contract with Browne Jacobson Solicitors was entered into on 1st September 2021 to provide lawyers to resource the team. The contract with Browne Jacobson will expire on 31 July 2024.

This report concerns the extension of the contract with Browne Jacobson up to 31<sup>st</sup> December 2026 to provide ongoing resources for the Designated Lawyer Team to enable the MPS to comply with its obligations in the Inquiry.

#### Recommendations

The Deputy Mayor for Policing and Crime, via the Investment Advisory and Monitoring meeting (IAM), is asked to:

 Approve the extension of the current contract with Browne Jacobson Solicitors for the period 1 August 2024 to 31 December 2026 in the sum of £1.622m. If approved, the current Browne Jacobson staff will remain in post with any replacement staff provided by Browne Jacobson if any should leave.

### Time sensitivity

Due to the restrictions on MOPAC activity as a result of the pre-election period and the consequent effect that this may have on completing contractual terms with Browne Jacobson Solicitors, a decision is required from the Deputy Mayor by 31 March 2024. This will enable contract terms to be adjusted and finalised prior to

services continuing from 1 August, 2024 and to ensure there is no break in legal support.

## Non-confidential facts and advice to the Deputy Mayor for Policing and Crime

## Introduction and background

- 1. The Designated Lawyer (DL) Team is a core participant in the Undercover Policing Inquiry. It is currently headed by a Senior Lawyer from the Directorate of Legal Services (DLS) who is assisted by a Legal Team Assistant also from DLS as well as two junior lawyers and a paralegal from Brown Jacobson Solicitors pursuant to a contract with Brown Jacobson agreed on 1<sup>st</sup> September 2021.
- 2. Prior to the current arrangement set out in paragraph 1 above, the Senior Lawyer heading the DL Team was assisted by seconded lawyers from different firms on short term contracts. This created instability in the team and impacted service delivery. The provision of lawyers from Browne Jacobson under the existing contract has provided a continuous and stable service to the officers supported by the DL Team. Browne Jacobson are required to replace any lawyers or paralegals who may leave ensuring that there is a significant hand over period so as to prevent any disruption to the service provided.

The extension of the contract to provide specialist legal services from one firm, Browne Jacobson Solicitors is cost-effective in this long running Inquiry as opposed to the previous unstable model of sourcing lawyers from different firms for short periods of time. This more sustainable approach is in accordance with the objective in paragraph 6.1 of the MOPAC Police and Crime Plan that the MPS is effective in its work and efficient in the use of its budget.

The proposal for the extension of the contract to continue to supply specialist legal advice for the Inquiry Team will not use personal data of members of the public any more or differently to that currently used so there are no additional GDPR issues to be considered.
