

# GREATER LONDON AUTHORITY ACT 1999

## TRANSPORT ACT 2000

### Greater London Low Emission Zone Charging (Exceptional Variation) Order 2024

*Made*

*21 August 2024*

*Coming into force*

*In accordance with articles 1(2) and 2*

Whereas—

- (1) the Greater London Low Emission Zone Charging Order 2006 as varied from time to time (“the LEZ/ULEZ Scheme Order”) imposes charges for the use of specified classes of motor vehicles on designated roads within a specified area of Greater London;
- (2) the LEZ/ULEZ Scheme Order was varied by the Greater London Low Emission Zone Charging (Variation and Transitional Provisions) Order 2022 as confirmed with modifications by the Greater London Low Emission Zone Charging (Variation and Transitional Provisions) Order 2022 Instrument of Confirmation 2022 (“the 2022 Variation Order”);
- (3) the 2022 Variation Order also contains transitional provisions including a transitional period during which certain community minibuses are to be treated as non-chargeable vehicles;
- (4) it appears to Transport for London desirable or expedient, for the purposes of facilitating the achievement of policies and proposals in the Mayor of London’s Transport Strategy published pursuant to section 142 of the Greater London Authority Act 1999<sup>(a)</sup>, that it should make an Order for the purposes of varying the 2022 Variation Order as it relates to the community minibuses transitional period:

Now, therefore, Transport for London, in exercise of the powers conferred on it by sections 295 and 420(1) of the Greater London Authority Act 1999, by Schedule 23 to that Act, and of all other powers enabling it in that behalf, hereby makes the following Order:—

#### **Citation and commencement**

1.—(1) This Order may be cited as the Greater London Low Emission Zone Charging (Exceptional Variation) Order 2024.

(2) This Order shall come into force immediately on the day following the day on which the Mayor confirms it.

## SCHEDULE TO THE ORDER

Article 2

### VARIATION SCHEME

#### **Certain community minibuses liability for ULEZ charge**

1.—(1) The Greater London Low Emission Zone Charging (Variation and Transitional Provisions) Order 2022, as modified by the Greater London Low Emission Zone Charging (Variation and Transitional Provisions) Order 2022 Instrument of Confirmation 2022, is amended as follows.

(2) In sub-paragraph 5(2)(b) of the Annex to the Variation Scheme, for “26 October 2025” substitute “24 October 2027”.
