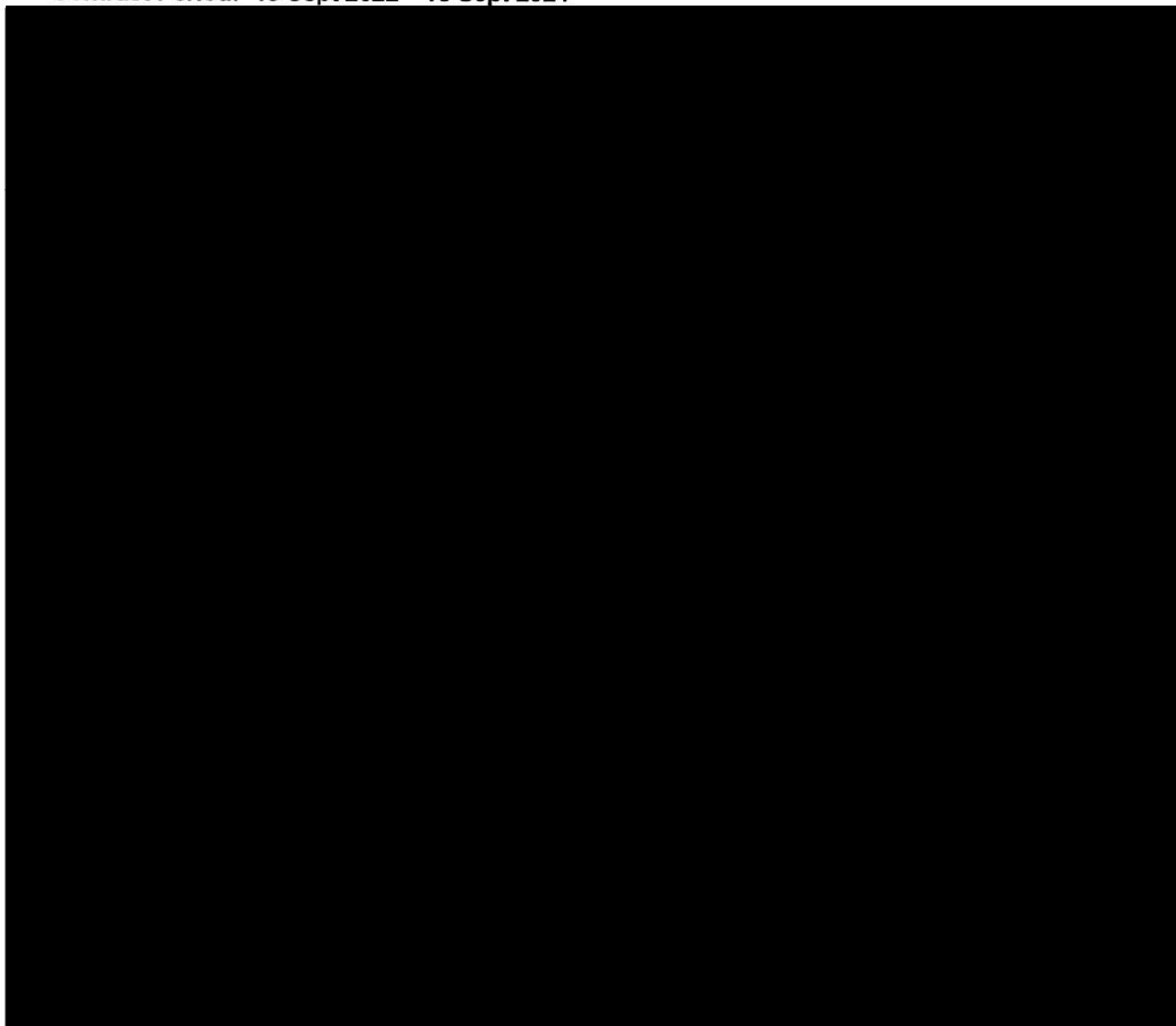

Schedule 1

1. Additional Output Specification for Trafalgar and Parliament Squares

Clause 4. Sustainability

1.1 General

- (i) The Contractor to support GLA's sustainability plans with delivery of the Veolia Sustainability Strategy Plan
- (ii) The GLA is committed to improving air quality in London. The Contractor shall support this aim wherever possible and will be required to identify and implement opportunities to reduce emissions associated with the delivery of services, over the term of the contract and where reasonably practicable to do so. For example, the use of low emission vehicles and minimising the level of vehicle movements.
- (iii) The Contractor shall throughout the term of the contract proactively look to identify new opportunities to reduce the amount of energy and water consumption in the delivery of the services.
- (iv) The Contractor shall follow the waste hierarchy: avoid producing waste where possible; reusing / repairing what can't be avoided; recycling the remainder and sending the minimum possible to residual waste. This includes minimising packaging in all products bought.
- (v) All on-street coffee cup recycling permitted only when predesignated viable supply routes are reported to ensure recycling with no incineration permitted

1.2 Cleaning Services

- (i) The Contractor shall minimise the need to use chemicals and other substances that have hazardous properties that have the potential to cause harm to human health and/or the environment.
- (ii) The Contractor shall minimise the use of disposable items and cleaning materials, e.g. the contractor should use reusable microfibre cloths.
- (iii) The Contractor shall ensure products are delivered with clear dosing instructions to avoid over-application by the user.
- (iv) The Contractor must deliver a training programme for staff on cleaning methods that are environmentally sustainable and comply with health and safety. This should cover cleaning agents, methods, equipment and machines used; waste and water management and aspects of health, safety and the environment.

- (v) Chemicals must comply with EU Ecolabel.

- (vi) Toilet paper and paper hand towels must be 100% recycled paper.

1.3 Horticulture

- (i) The Contractor shall ensure all activities undertaken in the delivery of the services avoid harm to biodiversity and the use of Glyphosates and Neonicotinoid Pesticides is strictly forbidden.
- (ii) The contractor shall use Pollinator-friendly and native plant species to enhance biodiversity.
- (iii) All products and services procured should comply with the latest version of the Horticultural Code of Practice covering invasive non-native plants:

- (iv) Peat products are prohibited, including in growing media, soil improvers, and supplied with plants purchased. Contractors will be expected to demonstrate composition and compliance of products.
