- GLA's evolution of its prospectus for future rounds and the efficiency with which it is able to enter into funding agreements with the proposed recipients.

### Legal adviser recommendation on the grounds for not publishing information at this time:

In the event of any request for access to the information contained in this document under section 1 of the Freedom of Information Act 2000 ("the Act") it is considered that access may be denied on the basis that the disclosure of such information risks prejudicing the commercial interests of applicants for and proposed recipients of GLA funding and the GLA itself, as its release would:

- provide bodies from whom proposed recipients from which they may seek to procure goods and services with knowledge of proposed project budgets and distort the market(s) for the same;
- publicise financial details of applicants for and proposed recipients provided in confidence which
  may impede their ability to optimise their leveraging of third-party funding or investment required
  for GLA funded or other projects; and
- by virtue of publicly acknowledging the potential availability of additional Brexit related contingency funding, prejudice the GLA's ability to optimise value for public money.

Therefore, the exemption from release of the information set out in part 2 of this report is covered by section 43 of the Act.

Section 1 of the Act creates the general right of access, which provides that any person making a request for information to a public authority is entitled:

- to be informed in writing by the public authority whether it holds information of the description specified in the request; and
- if that is the case, to have that information communicated to him/her.

Part II of the Act contains a number of exemptions from disclosure for certain classes of information. In particular, section 43 of the Act provides that information is exempt information, if its disclosure under

the Act would, or would be likely to, prejudice the commercial interests of any person (including the public authority holding it). The paragraph above states that the information could be considered commercially sensitive, as its release could affect the commercial interests of applicants for and the proposed recipients of GLA funding and the ability of the GLA to secure best possible outcome in respect of funding it awards, and therefore, is covered by the exemption under section 43 of the Act. The Section 43 exemption is a qualified exemption and, accordingly, its valid use is subject to a public interest assessment.

#### **Public Interest Assessment**

On balance it is considered that the public interest is best served if the information is not disclosed at this point. As noted above, disclosure by the GLA could, as explained above:

- have a detrimental effect on the commercial interests of applicants for and the proposed recipients of GLA funding;
- affect the GLA's ability to optimise value for money in its award of Skills for Londoners Capital funding; and
- cause unnecessary strain on public funds.

For these reasons, it is considered that the information below is exempt from publication in reliance upon the exclusions contained in section 43(2) (commercial interests) of the Act and because the public interest in withholding the information outweighs the public interest in releasing it.

### **Decision and/or advice:**

That the Executive Director of Development, Enterprise & Environment approves the ringfencing of up to £12m from the SfL Capital Fund to provide for a Brexit contingency endorsed by the LEAP.

This Decision is confidential and the confidential information and advice is presented in the below summary of the proposal and the results of the evaluation which is attached.

### 1. Confidential facts

1.2 The decision in this part 2 is for the ringfencing of £12m for Brexit contingency which was approved by LEAPIC and LEAP as part of the remaining Skills for Londoners Capital Fund (SfLCF) budget to provide for a programme contingency to address the potential delivery risks and uncertainties resulting from Brexit. Once there is greater clarity on the actual and potential impacts of Brexit, a set of rules and principles will be agreed in order to provide a governance structure for how this contingency is applied. This is reserved as if its availability is known about then projects may seek reliance on this rather than their own contingency. The expenditure and allocation of this will be subject to LEAPIC/LEAP endorsement and Director Decisions/ Assistant Director Decisions as appropriate as this decision merely approves the principle.

### 2. Finance Comments

2.1 The £12 million contingency recommended for approval means that taken together with the decisions in part 1, there is £8.65 million uncommitted of the £114 million Skills for Londoners budget approved in MD2142. As outlined above, if it can be demonstrated that the Brexit contingency is required for the delivery of projects, a methodology will be put in place to ensure this is drawn down consistently.
