Thank you for your letter following the London Assembly Plenary meeting on 5 December 2024, where the London Assembly agreed the following motion:

Motion 3.3 – Blue Badge Theft:

It is crucial to emphasise that all forms of theft, including Blue Badge theft, are unacceptable. The Mayor and I understand the detrimental impact these thefts can have on Blue Badge holders who rely on them to travel and live independently.

The Mayor and I have been clear in our newly published Police and Crime Plan for London about the importance of local policing. The Mayor has invested in boosting neighbourhood policing, increasing the number of Dedicated Ward Officers (DWOs) and Safer Neighbourhood Teams (SNTs). Their role is to know and be known to their community, and to work with residents and partner agencies to take a problem-solving approach to crime and ASB.


The Blue Badge scheme is administered and enforced by local authorities and therefore it is the responsibility of local authorities to address the issues related to detecting the fraudulent use of Blue Badges, and implementing improvements where needed. The Mayor will be writing to all London boroughs to request that they issue theft prevention advice alongside blue badges.

The MPS continues to encourage individuals to report their stolen Blue Badge promptly as this enables officers and their partners to investigate and take necessary actions swiftly. As part to the MPS's New Met for London plan, the MPS have committed to improving the speed and quality of their investigations. Detection of the fraudulent use of Blue Badges by local authorities is also critical in addressing this issue.

London Assembly (Plenary) Meeting 5 December 2024 – Motions

Thank you for your letter about the motions agreed at the London Assembly (Plenary) meeting on 5 December 2024. My reply to motions 3.3 and 3.4 is below.

Motion 3.3 – Blue Badge Theft

It is crucial to emphasise that all forms of theft, including Blue Badge theft, are unacceptable. I understand the detrimental impact these thefts can have on Blue Badge holders who rely on them to travel and live independently. This is one of the reasons why I have launched a new Robbery Reduction Partnership, a forum to reduce robbery and improve joint working between local businesses, London Councils, the Metropolitan Police Service (MPS), the Crown Prosecution Service, the Youth Offending Service, Transport for London, the Safer Business Network, London's Violence Reduction Unit (VRU), and the British Transport Police. This partnership will continue in 2025 to jointly tackle the pan-London issues we are seeing.

I have been clear that a focus on local policing is vital. I have invested in boosting neighbourhood policing, increasing the number of Dedicated Ward Officers and Safer Neighbourhood Teams. Their role is to know and be known to their community and to work with residents and partner agencies to take a problem-solving approach to crime and ASB.

The Blue Badge scheme is administered and enforced by local authorities, and therefore it is their responsibility to address the issues related to detecting the fraudulent use of Blue Badges and implementing improvements where needed. Motion 3.4 – Remembering Knife Crime Victims


Every young life taken due to knife crime is a tragedy, and I fully support the need to remember victims of knife crime across the capital and to recognise the impact of these terrible crimes on the families of those whose lives have been so cruelly taken and the wider community.

Knife Crime Awareness Week is an important moment each year, initiated by the Ben Kinsella Trust, to focus on the work we, our partners and the MPS do every single day to help tackle this important issue. Quite rightly, this includes remembering the victims and the wider impact of these terrible crimes.

I am clear that the safety of Londoners is my top priority, and I will do everything in my power to tackle the scourge of knife crime. That is why I set up and fund London's Violence VRU – the first in England and Wales – to pioneer a partnership approach to tackling violence that is rooted in prevention and early intervention. This includes additional youth workers, more support for families and local communities, and programmes for inside and outside school hours to divert young people away from violence and towards employment. Over the last six years, London's VRU has invested in more than 350,000 positive opportunities for young people. Since it was set up in 2019, there has been a 24% reduction in homicides, a 27% fall in knife injury of a person aged under 25, and a 17% reduction in personal robbery (compared to when the VRU was established). I have committed to investing in a further 250,000 positive opportunities for young Londoners over the course of my third term.

As our work to tackle knife crime continues, we will raise the idea of a dedicated day of remembrance for victims with the VRU, the MPS, the Ben Kinsella Trust, and other partners to seek a consensus on whether this is a helpful approach for families and communities affected and to help keep London safe.
