Thank you for your request for information which the Mayor's Office for Policing And Crime (MOPAC) received on July 25.

I can confirm that your request has been handled under the Freedom of Information Act 2000 and that MOPAC does hold some information relating to your request.

Our response is as follows:

The following data has been sourced from MOPAC Grant Management returns.

In 2022-23 MOPAC commissioned 7 Domestic Abuse Perpetrator Programmes, these were all jointly funded by MOPAC and the Home Office. MOPAC hold top level information on these funded programmes, used to inform grant management, for more detailed information requests should be made to providers.

Please note we have grouped related questions below, the answers to which are reflected in the table.

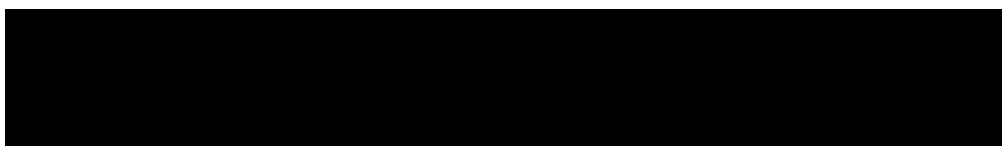

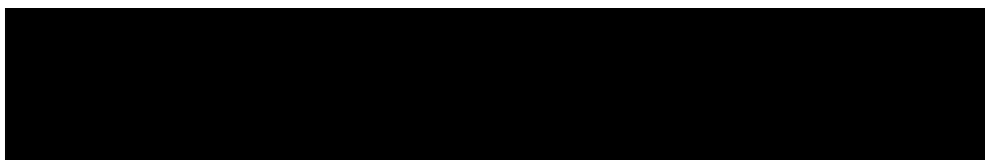
