

A Met Police spokesperson said: "Decisions on the tactical options that are appropriate ahead of any pre-planned event or protest are carefully considered and take into account a full intelligence, threat and risk assessment.

"Any suggestion that those decisions are taken based on the ethnicity of those likely to be in attendance at an event is not accurate.

"The decision to authorise baton rounds as an available tactical option is one that can only be taken by an Assistant Commissioner.

"It is primarily a preparatory step that provides the operational commander for the event with the ability to consider authorising its use where a situation involving a risk of either loss of life or serious injury develops, and after conventional methods have been tried and failed (or would in all of the circumstances not succeed).

"While authorisations have been given ahead of a very limited number of events and protests in recent years, baton rounds have never actually been used by the Met in a public order situation.

"In recent years, authorisation has been given to operational commanders to consider baton rounds as a tactical option for Notting Hill Carnival and for three days during protests in central London in 2020."

Notting Hill Carnival

Around one million people attend Notting Hill Carnival each year and most have a fantastic experience. We recognise its significance to communities across London as a celebration of the city's cultural diversity and history.

But it is that same unrivalled scale, the fact it takes place in a built up residential area rather than a dedicated event venue and the convergence of groups – in particular groups of young men – from across London and beyond, that makes Carnival such a unique policing challenge.

Each year thousands of officers are deployed to police the event, and while we work closely with the community, organisers and partners to ensure it can take place as safely as possible, we do have to acknowledge that the likelihood of violence and disorder is higher than at other events we police.

Last year, 74 officers were injured, there were a number of serious assaults on members of the public and tragically, a young man was murdered.

It is in this context that the decision has been taken, on a number of occasions, to authorise the availability of baton rounds as a tactical option to the officer in overall command of the policing operation.

Again, this is a preparatory step to ensure officers have the resources available to intervene quickly in the most serious circumstances. It is not the same as authorising their use.

Protests in central London in 2020

In the summer of 2020, the death of George Floyd at the hands of a police officer in Minneapolis prompted significant protests, first in the United States and then in other cities around the world, including London.

While the majority of protests in London were peaceful, there had been outbreaks of disorder and by 10 June, more than 40 officers had been injured.

As part of a wider policing plan, authorisation was given for baton rounds to be available to the overall policing commander, as a tactical option, between 12 June and 15 June.

This was prompted by serious concerns about a further escalation in disorder with large numbers of people anticipated and an indication that counter protesters could travel to London leading to potential confrontations between groups.

While baton rounds were available as an option, there was no eventual need for their use to be authorised.

We provided a briefing earlier this week on an FOI from the Guardian about our deployment of baton rounds. We understand the Mayor is issuing the following line, which is really unhelpful. Baton rounds are often pre-authorised for NHC, and MOPAC have been regularly briefed about this, so the suggestion that it is a new thing which needs raising with senior Met leaders is wrong: A spokesperson for the Mayor of London said: "The approval of the tactical option of baton rounds in these events only is very concerning and the Mayor will be raising this matter with senior Met leaders. The Met must account for their decision making – and Black Londoners will rightly want to know that they are being treated equally.

Ahead of NHC it risks raising community concerns and tensions, as well as limiting operational tactics.
