The figures included in this report are directly related to the amount of funding available to complete procurement actions, this is sensitive as suppliers tendering could adjust their prices higher to utilise more of the budget available.

#### Legal adviser recommendation on the grounds for not publishing information at this time:

In the event the information contained in this Part 2 is the subject of a request for information under section 1 of the Freedom of Information Act 2000 (the Act), it is considered that access may be denied on the basis that such information constitutes exempt information under section 43(2) of the Act.

Section 43(2) of the Act provides an exemption from disclosure where the release of such information would, or would be likely to, prejudice the commercial interests of any person (including the public authority holding it).

#### **Public Interest Assessment**

On balance, it is considered that the public interest in maintaining the exemption is greater than the public interest in disclosing the information contained in this Part 2 report. This is because disclosure by the LFC of the information contained in this Part 2 report before completion of the works for each project would be likely to have a detrimental effect on the LFC's commercial position and ability to secure best value in the procurement of the works and services detailed in the Part 2 report. The recommended period for non-publication of Part 2 is post the completion of the projects outlined, which is anticipated to be in March 2025.

# Confidential decision and/or advice:

This report requests that the Deputy Mayor for Fire and Resilience authorises the London Fire Commissioner to commit capital expenditure of up to £1.759m for the additional requirements for the Plumstead Fire Station refurbishment project and Lambeth River Station remedial works.

# Breakdown of cost for additional expenditure

The underspends from the capital programme outlined below will be used to support enhanced specification for Plumstead Fire Station and cover the costs of linkspan disconnection and provide contingency for the Lambeth River Station project, as detailed in this report.

# Lambeth River Station project

LFC-0379 approved commitment of capital of up to £3,800,000 for the Lambeth River Station remedial works. An increased budget is required for Lambeth River Station to make provision for project contingency and to cover the required linkspan disconnection. Inclusive of the proposed additional expenditure it will bring the total funding available for the remedial works to £4,371,822. The table below sets out details of the additional proposed expenditure:

# Plumstead refurbishment project

LFC 0263x authorised expenditure of up to £6,195,000 to refurbish and extend Plumstead Fire Station. LFC-0715 authorised a further £803,078 of capital expenditure to bridge the gap between the tender submission and the approved budget. This brought the total funding available for the project to £6,998,078.

The specification of Plumstead Fire Station requires further additional funding to include decarbonization measures and address unforeseen costs, including a party wall settlement. The individual components which compromise a total request of £1,256,950 are shown below:

#### Finance comments

The LFC report aims to secure approval to use £1,759m of the £1.869m anticipated underspend relating to capital delivery programme for 2022/23 and 2023/24 detailed within LFC reports LFC 0533y and LFC 0614y (and set out in the table below) to fund the following projects:

River Station and Lambeth repairs	£502,177
Plumstead	£1,256,950

The anticipated underspend would, if achieved, adequately cover the additional £1,759,127 capital expenditure required resulting in no financial impact on the capital programme medium term plan. The table below shows a high level status of progress in regard to the forecast underspends

Approximately 47% (£870,000) of the forecast underspend is now confirmed. On this basis, Property Services are confident the additional expenditure required can be provided for from within existing resources. In the unlikely event the overall underspend is lower than forecast, the capital programme has unallocated funds in each financial year which can be deployed during the lifespan of the programme.

The report below provides details of the completed projects within the LFC reports LFC 0533y and LFC 0614y and the estimated savings. This enables proper assessment of the financial impact of this reprofiling on the capital programme.
