

## **Estate regeneration projects where the GLA approved funding prior to introducing the Resident Ballot Requirement on 18 July 2018**

This list contains details of planned or current estate regeneration projects named in a signed funding contract with the GLA, and the decisions associated with them, prior to 18 July 2018. This is based on the information that the GLA has on record at a particular point in time and is likely to be partial and subject to change and should not be seen as a definitive list of all estate regeneration projects in receipt of GLA funding. Projects on this list may be subject to a ballot unless they seek an exemption from the GLA, or they fall beyond the scope of the ballot funding condition. The approximate number of homes detailed for each project below includes both affordable homes the GLA is funding and other homes being delivered without GLA funding (such as private homes). As of November 2025, the GLA will no longer be updating the approximate number of new homes on the previously approved estate regeneration schemes published in this list. Residents looking for further information about regeneration schemes on this list should speak to their landlord.
