GRANT VARIATION FOR: Skills Bootcamp W6 – con_26673 (FY2025-26)

The variation order to our Grant Funding Agreement to take effect from 1 April 2025 is as follows:

Variation to the Grant Funding Agreement with: Greater London Authority

This variation to the Grant Funding Agreement is in order to increase the amount of funding from that offered in the original Grant Offer.

The increase in funding set out in this letter is to support additional Skills Bootcamps delivery in Construction Skills.

1) Page 2, Para 3 of the Grant Funding Agreement is amended to read as:

I am pleased to inform you that the Department is willing to offer you funding of up to **£29,993,560.70** (Twenty Nine Million, Nine Hundred and Ninety Three Thousand, Five Hundred and Sixty Pounds and Seventy Pence). Of which, **£2,965,329.43** (Two Million, Nine Hundred and Sixty Five Thousand, Three Hundred and Twenty Nine Pounds and Forty Three Pence) is specifically to support construction Skills Bootcamps in addition to those already planned through your original grant. The grant value includes a total of **£2,862,447.50** (Two Million, Eight Hundred and Sixty Two Thousand, Four Hundred and Forty Seven Pounds and Fifty Pence) in relation to management costs, for the year period from 1st April 2025 to 31st March 2026, which will be paid in accordance with the Grant Payment Schedule.

- 2) **Page 4, special condition (5) is suspended for the additional grant allocation**, which is available for construction skills only.
- 3) **Page 4, special condition (7) is amended** to refer to 8478 learners in total, including 774 construction learners directly supported by this increase in grant allocation.
- **Page 4/5, special condition (8) a**, date amended to 'on or before 1 July 2025'; and b, to August 2025.
 - **Page 5, special condition (9)**, first sentence amended to: at least 20% of learner starts must occur by 30th September 2025 (to be reviewed by 15th October 2025); and 50% of learner starts must have occurred by 30 November 2025 (to be reviewed by 15th December based on data reporting provided to your Grant Manager or through the ILR).
- 4) **Page 15, numbers in the table are amended to** 8478 Learner Starts and 6782 Learner Completions.

We agree that all other terms and conditions of the Grant Funding Agreement remain unaltered and that no other liabilities, financial or otherwise, shall accrue to the Department because of the above amendment. We confirm acceptance of the variation on the terms specified above.
