MOPAC has funded Redthread at a value of £360,257 between April 2016 and March 2017 and £300,000 between April 2017 and March 2018. This information is exempt from publication under Section 21 as it is already published, here:

A DMPC decision was signed on 19th March 2018 agreeing £555,000 funding via a grant agreement to Redthread supporting the continuation of clinically embedded youth work In London's four Major Trauma Centres from April 2018 - March 2020. This decision will be published in due course on the MOPAC website (<u>https://www.london.gov.uk/what-we-do/mayors-office-policing-and-crime-mopac/governance-and-decision-making/mopac-decisions</u>).

There have been two evaluations of the work Redthread and St Giles Trust (St Giles Trust are subcontracted by Redthread to provide the service in Royal London hospital). There was an interim evaluation in September 2016 and a further evaluation in August 2017. These evaluations are exempt from disclosure under Section 22 of the Freedom of Information Act, since they are intended for future publication, here:
