Issues for consideration

2. The following item is to be considered for approval:

Strategic Change in the MPS – Consultancy Support
The paper seeks additional 'capped' funding for the provision of services of a Strategic Partner who will support the Portfolio Transformation Office in managing delivery of the Met's change portfolio over the next 2 years. The proposal includes a Performance Based Specification (PBS) that will be used as part of a competitive process to appoint a Strategic Partner. It is proposed that a competitive process is used to select the Strategic Partner through the NEPRO contract, which was approved in September 2015 by MOPAC as the MPS route to market for consultancy services
