This is attached with redactions. Redactions have been made for the following FOIA exemptions:

Section 40(2) Data Protection. This is an absolute exemption, therefore no Public Interest Test is required.

Section 31 Law Enforcement. This is a prejudice exemption and is subject to the public interest test.

Disclosure of the information could compromise security arrangements at the storage site and as such could hinder the prevention or detection of crime

While it is in the public interest to be transparent and accountable, in this case the public interest is better served if the information is withheld, in the interests of public safety and the prevention of crime.

7. Any correspondence with Reclamations Ollerton on the three vehicles and their disposal.
