- "My query was in relation to communications between Pastor Adeboyega / SPAC Nation and the Mayor of London and the 25 elected London Assembly Members {most notably starting with Croydon representative}
- -The Mayoralty I am asking of is Mayor Sadig Khan (May 2016-present).

My request relates to -invitations to events

Themes regards to:

- -gang prevention
- -young people
- -knife crime\ police
- -opportunities for youth

funding for projects\such as:

- -Young Londoners Fund
- -Mayor's Fund for London"

Our response to your request is as follows.

# Communications – Mayor of London

We have searched our records and we have not located any direct correspondence to/from the Mayor of London to Pastor Adegboyega or SPAC Nation.

We located an invitation mailout which was sent to various people including Pastor Adegboyega last year. We do not have the email sent to Pastor Adegboyega on file, but we have a copy of the email he would have received which is attached.

Please note that some names of members of staff are exempt from disclosure under s.40 (Personal information) of the Freedom of Information Act. This information could potentially identify specific employees and as such constitutes as personal data which is defined by Article 4(1) of the General Data Protection Regulation (GDPR) to mean any information relating to an identified or identifiable living individual. It is considered that disclosure of this information would contravene the first data protection principle under Article 5(1) of GDPR which states that Personal data must be processed lawfully, fairly and in a transparent manner in relation to the data subject.

We do not hold information within the scope of your request.


