MAYORAL DELEGATION TO TfL OF HIGHWAYS WORKS CONCERNING THE RELOCATION TO THE CRYSTAL

Background

- A. Mayoral Decision (MD) 2705 approved the relocation of the Greater London Authority (GLA) from City Hall to The Crystal in the London Borough of Newham ("LBN") and delegated authority to GLA officers to enter into agreements under section 106 of the Town and Country Planning Act 1990 and section 278 of the Highways Act 1980.
- B. The planning permission granted by LBN (application reference 20/02288/FUL) requires the GLA to carry out, or secure the carrying out, of certain improvement works to LBN's public highways ("the Highway Works") under a s 278 Agreement to be concluded between the GLA and LBN ("the s 278 Agreement") to be carried out by a contractor.
- C. The "Highway Works" include the provision of a vehicular rejection lane, relocation of the existing pedestrian crossing and other associated highways works.
- D. To expedite the carrying out of the Highway Works it has been agreed that Transport for London (TfL) will appoint and manage a contractor on behalf of the GLA.
- E. In order for TfL to undertake this role it is necessary for the Mayor to delegate to TfL the performance of the GLA's obligations under the s 278 Agreement and his general and subsidiary powers under sections 30 and 34 of the Greater London Authority (GLA) Act 1999 (as amended) for that purpose.

Delegation

1. The Mayor authorises and delegates to TfL, to be exercisable on the GLA's behalf, under section 38(1) and (2) of the GLA Act 1999:
 - a. the GLA's functions and obligations under the s278 Agreement concerning the execution and completion of the Highways Works under that Agreement, and for connected purposes; and
 - b. the GLA's functions under sections 30 and 34 of that Act for that purpose;("the Delegation") subject to the terms and conditions set out in paragraph 2.
2. The Delegation is made subject to the following conditions.
 - (1) The Highways Works carried out by or on behalf of TfL in implementing the delegation will be the subject of regular updates and reports to the Mayor or relevant GLA officers as appropriate on progress and developments;
 - (2) The powers conferred by the delegation are without prejudice to any powers or functions TfL otherwise has at common law or under any relevant legislation and the functions delegated by the Mayor shall be exercisable by TfL in accordance with section 38(7) of the GLA Act 1999;
 - (3) In implementing the delegation TfL will comply with any instructions or guidance issued by the Mayor or by GLA officers; and
 - (4) TfL shall at all times afford the person who is the GLA's Monitoring Officer for the time-being with all reasonable co-operation and access to documents and facilities as may be required from time to time in respect of that person's duties as Monitoring Officer to investigate and prepare reports under section 5(2) of the Local Government and Housing Act 1989 (as applied by section 73(6) of the GLA Act 1999).
