I would like to request some information under the Freedom of Information Act 2000. Please acknowledge receipt of my request by email.

Please provide details of:

- 1a) data on funding that Mayor's Office for Policing and Crime has allocated to activities related to human trafficking and/or modern slavery (for example, but not limited to: a dedicated unit, staff training, prevention, investigation, prosecution, awareness campaigns) for the years 2012-13, 2013-14, 2014-15, 2015-16, 2016-17. If this is not possible or too broad please refer to 1b)
- 1b) data on any funding that Mayor's Office for Policing and Crime has allocated to activities related to human trafficking and/or modern slavery (for example, but not limited to: a dedicated unit, staff training, prevention, investigation, prosecution, awareness campaigns) since 2012. If this is not possible or too broad, please refer to 1c)
- 1c) data on any funding Mayor's Office for Policing and Crime has allocated to activities related to human trafficking and/or modern slavery (for example, but not limited to: a dedicated unit, staff training, prevention, investigation, prosecution, awareness campaigns) in 2014-15.
- 4)If Mayor's Office for Policing and Crime hasn't allocated any funding specifically to activities related to human trafficking and/or modern slavery (for example, but not limited to staff training, prevention, investigation, prosecution, awareness campaigns) since 2012 please confirm that in writing.
- 3a) Please provide details of the time period covered by Mayor's Office for Policing and Crime's latest Police and Crime Plan.

- 4) If Mayor's Office for Policing and Crime hasn't had/doesn't have a plan specifically dedicated to human trafficking and/or modern slavery since 2012, can you please confirm that in writing.

I would remind you that under your Section 16 duty to advise and assist I would expect you to contact me to discuss any practical difficulties that you may have in fulfilling this request so that I may narrow my request in a way that works for both of us.

If FOI requests of a similar nature have already been asked could you please include your responses to those requests.

I would be grateful if you could confirm in writing that you have received this request, and I look forward to hearing from you within the 20-working day statutory time period.

## **RESPONSE**

Thank you for your Freedom of Information request of 11 January to the Mayor's Office for Policing And Crime (MOPAC). I confirm that your request has been handled under the Freedom of Information Act 2000 and that MOPAC does hold some information relating to your request as set out below:

1a) data on funding that Mayor's Office for Policing and Crime has allocated to activities related to human trafficking and/or modern slavery (for example, but not limited to: a dedicated unit, staff training, prevention, investigation, prosecution, awareness campaigns) for the years 2012–13, 2013–14, 2014–15, 2015–16, 2016–17. If this is not possible or too broad please refer to 1b)

MOPAC does not have a dedicated unit for human trafficking or modern slavery. MOPAC has not undertaken staff training in this area.

It is not the legal responsibility of MOPAC to undertake investigations or prosecutions on this area. (This responsibility sits with the Metropolitan Police Service (MPS) and criminal justice partners)

MOPAC has not run an awareness campaign on this issue, however it was highlighted as an area of concern and priority in the Mayor's Violence Against Women and Girls (VAWG) Strategy.

MOPAC has not allocated any funding specifically to activities relating to human trafficking and or modern slavery. However, approximately  $\pounds 10$  million of MOPAC funding this year is addressing Violence Against Women and Girls. This covers projects and programmes directly commissioned by

MOPAC centrally and projects and activities undertaken by local boroughs using London Crime Prevention Funding which is administered and managed by MOPAC.

3a) Please provide details of the time period covered by Mayor's Office for Policing and Crime's latest Police and Crime Plan.

The Police and Crime Plan covers the period of 2013-2016.

3b) Does the latest Police and Crime Plan include any reference to human trafficking and/or modern slavery? Please answer yes or no.
