
#### Introduction


In November 2008 the Mayor launched his new draft Equality Framework – Equal Life Chances for All. It was developed to address the remaining and significant pockets of deprivation and inequality, and provides a fresh analysis and different solutions to community cohesion and tackling disadvantage. It aims to achieve equal life chances for all and proposes an approach that brings Londoners together, rather than dividing them.

Extensive consultation in winter 2008/09 included web-based feedback, roundtable discussions, focus groups and meetings with stakeholders at City Hall to stimulate debate and generated a large number of responses, with the majority welcoming this new approach.


This document outlines the findings from the consultation. There were 72 responses in total representing a wide range of stakeholders from London boroughs, public, private, voluntary and community sectors.









# Tone of responses



# Willingness to be involved




