Thank you for your request for information which the Greater London Authority (GLA) received on 3 February 2022. Your request has been considered under the Freedom of Information Act 2000.

You requested:

- 1. What was the Mayor of London's total budget for adult and child Mental Health schemes/activities for each year (2016-2021)?*
- 2. What was the Mayor of London's total spend for mental health schemes/activities for each year (2016-2021)?*
- 3. Please can you list the current adult and child Mental Health Schemes that the Mayor of London has committed funds to, and breakdown the amounts allocated to each?*

Please find below the information we hold within the scope of your request.

The GLA is taking a prevention-focused approach towards improving the public's mental health through the [Thrive LDN partnership](#); a citywide movement to ensure all Londoners have an equal opportunity to achieve good mental health.

Thrive LDN are the Mayor of London's primary delivery vehicle for mental health and are leading the Mental Health and Wellbeing Mission as part of the [London Recovery Programme](#). There is however a broader programme of work that is mainstreamed across the GLA that aims to support good mental health but it is difficult to separate this work out and therefore we have been unable to list all of this activity in this request within the "appropriate limit" specified in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulation 2004 SI 2004 No 3244. These are known as the 'Fees Regulations' for brevity.

To give a sense of this mainstreamed activity, certain programmes delivered through, but not limited to the following teams and departments will seek to support positive mental health for Londoners: Education and Youth, Social Integration, Team London, Housing and Land, Sports, Mayors Office of Policing and Crime, Equality and Fairness, Skills, Environment, Culture, Transport for London, Violence Reduction Unit.

London's total budget for adult and child Mental Health schemes/activities for each year (2016-2021)

We have made two assumptions whilst preparing the supporting information:

1. Thrive LDN's schemes / activities are mostly universal, rather than split into adult and child groupings. Therefore, the best way in which to respond to this request is to disclose overall Thrive LDN schemes / activities. *Activities have been highlighted if they have a specific focus on child mental health.
2. That 'current' means schemes / activities delivered in 2021/22 financial year, i.e. activities covered in the most recent Mayoral Decision
