Decision required

1. Introduction and background

- 1.1. The proposed Directions are attached at Appendix 1. They were discussed and agreed in advance with the Electoral Commission, legal advisers, Constituency Returning Officers (CROs), Borough Returning Officers (BROs) and Electoral Services Managers (ESMs).
- 1.2. The purpose of the Directions is to ensure that the delivery of the Mayor of London and London Assembly elections complies with the law and Electoral Commission guidance and performance standards; and to ensure a consistency of experience for voters, candidates and agents.
- 1.3. The Directions thus provide the GLRO with confidence that CROs are working to an agreed consistent standard and reduce the risk of a challenge to the conduct of the election.
- 1.4. The Directions are similar to those developed for 2020, prior to the 2020 election's postponement. They also now include a Direction relating to the COVID-19 pandemic.

2. Issues for consideration

2.1. All key stakeholders have been consulted and agreement reached that the Directions, allow each CRO to discharge their functions in accordance with relevant legislation.
