Thank you for your request for information which the GLA received on 5 June 2019. Your request has been dealt with under the Environment Information Regulations (EIR) 2004.

You asked for;

- 1. All documents pertaining to planning applications for the gas works site in Southall, west London, between 2005-2012
- 2. Environmental statements pertaining to planning applications for the gas works site in Southall between 2005-2012
- 3. Minutes of meetings between Mayor Boris Johnson and National Grid in that period
- 4. Minutes of meetings between Mayor Boris Johnson and his planning advisers pertaining to Southall gas works in that period
- 5. All documents pertaining to Mayor Boris Johnson's decision to call in 'special powers' to overturn Ealing decision to refuse planning permission on the site.

Our response to your request is as follows:

The GLA holds a volume of information within scope of part 1 and part 2 of your request and I am in the process of uploading this information to our disclosure log on the link below.
