Background

- The original outline applications were considered by the Mayor in 2013, comprising 1,128,831 sq.m. of floorspace, approximately 6,775 residential units, including 1,500 affordable units (22%). This includes replacement of the existing 760 affordable units in LBHF estates.
- The detailed application for the first phase of the new Earls Court (including demolition of the exhibition centre), featuring 1,200 new homes, 3.35 acres of publicly accessible park, and the first phase of the new High Street, was approved by RBKC and LBHF in April 2014. Demolition of the Exhibition Centre is now underway.
- The separately approved Seagrave Road development (marketed as Lillie Square) has commenced construction. It is intended to relocate some LBHF estate residents here.
