## Appendix A

## Quality assurance process

The quality assurance process comprises three stages:

- Stage One: The Senior Data Analyst drafts code to produce any new statistical tables and data file to ensure consistent results across publication and minimize manual edits on data outputs. This includes code to implement disclosure controls. During this stage, the Economist will confirm code logic and check results by replicating statistical tables for all tables that are new or have substantive changes to methodology. In the case of Borough Data, a sample check may be conducted. During this stage, the Senior Data Analyst and Economist may suggest minor amendments to table specifications to better represent the data and jointly draft notes for new or amended data tables as necessary.
- Stage Two: The Supervisory Economist reviews and tests statistical tables and other outputs, approving or rejecting any proposed amendments to table specifications. The Economist drafts an explanatory note to accompany the data file, which the Supervisory Economist reviews.
- Stage Three: The Assistant Director of Skills & Employment final sign off on all outputs. The outputs may additionally be submitted to the GLA's Chief Statistician, currently the Demography and Policy Analysis Manager, for review and approval.

In accordance with the UK Code of Practice for Statistics, this process may be amended with approval of the Assistant Director of Skills & Employment, the Senior and/or Supervisory Economist and the GLA's Chief Statistician.
