I write further to my email last week regarding your request for information about Boris' Johnson's Register of Interests in which I explained that we would be considering your request under the Freedom of Information Act. I can today provide you with our response.

To quickly confirm, your email of 3 April asked:

I'd be grateful if you could provide me a copy of all versions of Boris Johnson's register of Mayor's interests from the time he took over. I see his last register is public already, but I'd like to get hold of all others you have on record too.

Please find accompanying this letter a copy of the relevant submissions that we hold in relation to your request covering Boris Johnson's second term as Mayor of London.

We are releasing this information to you in full, but we have made some minor redactions to remove third-party personal data in accordance with the provisions of section 40(2) of the Act.

In two instances, we have redacted the names of junior GLA staff as this information could potentially identify current and former member of staff and the disclosure of which would constitute unfair processing of their personal data.

The remaining redactions have been made to withhold personal data relating to Boris Johnson from the *Sensitive Pecuniary Interests* sections of the forms we hold, specifically to withhold the addresses which were provided in relation to section 4 of these forms. The withheld addresses constitute the personal data of the former Mayor of London and related third-parties, and consequently also fall within the exemption provisions under section 40(2) of the Act.

We do not consider that the disclosure of these addresses would serve any wider public interest (such as furthering or informing a public debate, for example) without unduly infringing on the rights and protections provided under the General Data Protection Regulations (GDPR) and Data Protection Act 2018 in respect to the handling and processing of personal data.

We consider that the public interest is met in this instance by the GLA releasing the forms in full (other than these minor redactions) as part of our commitment to the openness and accountability of our processes and decisions, and the transparency of the how the Standing Register of Interest declarations and made and recorded.

The Mayor and Assembly Members must declare their interests in the Standing Register of Interests for which the latest version is published on line. If their interests change, an updated notification must be sent to the Monitoring Officer within 28 days and we then update the online version of the form.
