## Decision required – supporting report

1. Introduction and background

- 1.1 The National Driver Offender Retraining Scheme (NDORS) provides a mechanism through which police forces across the UK can make a discretionary offer to offenders who commit some road traffic offences to undertake retraining as an alternative to receiving a fine and/or points on their licence.
- 1.2 The research into diversionary courses show that they contribute well to road safety by producing positive changes to driving behaviour and instil confidence to drive safely.

#### 2. Issues for consideration

- 2.1 Following the disbandment of ACPO, (within which NDORS previously sat) and in response to the increasing demand for diversionary courses the decision was taken to create a not for profit company known as the "Road Safety Trust" to manage and administer the scheme. All Police forces/PCCs in England, Wales and Northern Ireland have been invited to be members of the company; each will hold a unit share.
- As a member of the scheme MOPAC/MPS will continue to benefit from using diversionary courses as a discretionary offer to offenders who commit some road traffic offences, but will have the added benefit of being able to directly input into how the Trust operates and delivers its objectives.
- 2.3 Every other PCC has taken a positive decision to allow their chief constable to join.
