# Title: Extension of Capgemini contract Email services

#### Executive Summary:

The MPS is seeking approval to extend the Email service contract with Capgemini for a period of up to 9 months.

#### **Recommendation:**

The Deputy Mayor for Policing and Crime is asked to

- 1. Approve the extension of Capgemini ICT agreement for the provision of Email services for the period September 1<sup>st</sup> 2017 to December 31<sup>st</sup> 2017. The cost of this extension will be funded from existing resources. This extension will be required in full.
- 2. The further extension of the Capgemini ICT agreement for the provision of Email services for the period up to six months from January 1<sup>st</sup> 2018 to June 30<sup>th</sup> 2018, for as many months as required, following confirmation of the Office 365 email migration schedule.
- 3. To delegate authority to the Commercial Director (Procurement) to extend the Capgemini contract service, as above.

## Extension of Capgemini Contract for Email Services

**Executive Summary** The Metropolitan Police Service is seeking approval to extend the email service in the Capgemini contract for up to a further 9 months

#### Time Sensitivity

A decision is required by the end of September 2017 in order to progress the further contract extension

# A. RECOMMENDATIONS - That the DMPC:

- 1. Approves the extension of the Capgemini ICT agreement for the provision of Email for the period 1st September 2017 to 31st December 2017, within existing resources. This extension will definitely be required in full.
- 2. Approves the extension of the Capgemini ICT agreement for the provision of Email for the period 1st January 2018 to 30th June 2018, for as many months as are required, following confirmation of the Office 365 email migration schedule.
- 3. Delegates authority to the Commercial Director (Procurement) to extend the Capgemini contract service, as above.

# **B. SUPPORTING INFORMATION**

- 1. The contract has previously been extended by three months (from the original planned cessation date and transition to O365) under delegated approval by Director, Commercial Services.
- 2. Part 2 is now a modified version of the paper originally approved at PIB in August 2017, as MOPAC have requested that the paper should address the total extension of the contract from October 2017 to June 2018.
- 3. Email underpins virtually all of the work undertaken by the MPS, both internally and externally, which means that the service must continue without interruption. There are no technical issues with the extension of the MaaS service, as it is a continuation of what exists currently.
- 4. The MPS is currently running a project to move Email services to Microsoft's Office 365 service, but the migration of user accounts has not yet started and, therefore, the existing email service will be required until migration is complete, which is currently expected to be by June 2018.
- 5. As detailed in Part 2, there is no practical technical or contractual alternative to continuing to use the Capgemini service, hence the requirement for this extension.
