This will include 800 residential units, retail units, offices, restaurants, pubs and take-away, hotels, school, health centre and new leisure facilities. Works will include access roads, parking, sewer systems, infrastructure, enabling works, improvements to public transport interchange, open space, rivers and water features and landscaping.*
