Title: Hendon Estate – Professional Services Support

Executive Summary:

As a result of increases in the scope and duration of the redevelopment of the Hendon estate this paper requests the retrospective approval of an increase in the fees for professional support.

Recommendation:

The DMPC is asked to retrospectively approve an increase in the E C Harris contract value from \pounds 423,000 to \pounds 993,365. This increase is contained within the previously approved budget for the Hendon redevelopment.

PART I - NON-CONFIDENTIAL FACTS AND ADVICE TO THE DMPC

Decision required – supporting report

1. Introduction and background

- 1.1. The Hendon Estate Strategy was approved by the Metropolitan Police Authority (MPA) on 15 December 2011 and subsequently endorsed by the Mayor's Office for Policing And Crime (MOPAC). The agreed strategy was to sell c22ha of surplus land and to reinvest part of the proceeds into a new 21,000 sq m facility on the retained part of the site.
- 1.2. On the 18 October 2012, following MPS support MOPAC approved the addition of a 50m firing range. The value of the Hendon redevelopment was further increased for disposal and Community Infrastructure Levy (CIL) costs and remediation costs.

2. Issues for consideration

- 2.1. As the Hendon Estate project has developed there have been a number of specific increases to the contract value as set out in Appendix 2. The proposed revised contract value of £993,365 includes a contingency of £50,000.
- 2.2. The contractor has added benefit and value to the overall Hendon development estimated at £5m.

3. Financial Comments

3.1. The proposed contract value will be contained within the approved Hendon budget. If approved the contract value will increase from \pounds 423,000 to \pounds 993,365. The initial award was via a competitive process, and the rates from this initial award continue to apply.

4. Legal Comments

- 4.1. This should be treated as a contract variation to:
 - 4.1.1. Increase the value of the contract from £422k to £993,365 and
 - 4.1.2. Increase the original scope of the contract to deal with the change in range of services.
- 4.2. See Part 2 for further detail.

5. Equality Comments

- 5.1. All Equality and Diversity implications were considered by Crown Commercial Services (CCS) who completed the original tender process for the Framework Agreement.
