Title: Home Office Grant Funding – Communications and Data Manager, and Regional Organised Crime Threat Assessment

Executive Summary:

This paper proposes the acceptance of HO grant funding to part fund for 2020/21 the Regional Organised Crime Threat Assessment (ROCTA) function upto £328,945, and to part fund for 2020/21 the Communications and Data Account Manager (CDAM) role upto £75,000.

Recommendation:

The Deputy Mayor for Policing and Crime is recommended to:


1. Approve the receipt by the MPS of £328,945 of Serious and Organised Crime (SOC) grant funding to enable the establishment of the London ROCTA during 2020/21
2. Approve the receipt of £75,000 of grant funding from the Home Office for 50% of the staff costs of a MPS Superintendent plus associated costs, for the period 01/04/2020 to 31/03/2021

PART I - NON-CONFIDENTIAL FACTS AND ADVICE TO THE DMPC

1. Introduction and background

Regional Organised Crime Threat Assessment (ROCTA)

- 1.1. The national ROCTA network was formed in response to HMIC's PEEL: Police effectiveness 2016 (national overview) which found the mapping of organised crime groups to be unacceptably inconsistent, giving an incomplete and inaccurate picture of the SOC threat.
- 1.2. Such teams already exist in the other nine policing regions of England and Wales and their establishment was supported by Police Transformation Fund (PTF) monies from which London did not benefit.
- 1.3. This paper proposes acceptance of HO funding to part fund the establishment and on-going costs of this function in London.

Communications and Data Account Manager (CDAM)

- 1.4. The Home Office have funded the CDAM role since 2015 as part of a wider grant funding arrangement for Communications Capabilities Development (CCD) Programme. This funding expired on 31 March 2020. The HO have now issued a new grant agreement for funding of the CDAM for the next financial year (FY20/21).

2. Issues for consideration

Regional Organised Crime Threat Assessment (ROCTA)

- 2.1. The new London Regional Organised Crime Threat Assessment (ROCTA) team will be a three force partnership – MPS, City of London Police (CoLP) and British Transport Police (BTP). It will incorporate the Met's existing Organised Crime Group Mapping (OCGM) team.
- 2.2. The London ROCTA is to provide a single regional capability that will assess, understand and manage the threat and risk from SOC across London. It will provide:
 - A complete view by threat of demand, risk and resource in London.
 - A consistent approach to the management of risk and tasking capabilities
- 2.3. The Met have already begun operating on the basis of the above arrangements.

Communications and Data Account Manager (CDAM)

- 2.4. The role of Communications and Data Account Manager (CDAM) within the MPS is to work closely with the National Communication and Data Service (NCDS) of the Home Office in promoting the use of Communications Data for policing purposes within Law Enforcement Agencies and key stakeholders
- 2.5. The Met have continued to operate this role on the basis of the above arrangements.

3. Financial Comments

Regional Organised Crime Threat Assessment (ROCTA)

- 3.1. The ROCTA function is estimated to cost £653k for 2020/21. At £328,945 the HO grant will cover 50% of the staff costs of the expanded team for 2020/21. Existing regional organised crime funding will meet a further 14% of the costs, with the remaining 36% being met from within MPS existing budget.
- 3.2. The model of SOC funding nationally is being reviewed and the MPS, CoLP, BTP and the National Police Chiefs Council (NPCC) SOC Portfolio are working together to determine sustainable funding arrangements.

Communications and Data Account Manager (CDAM)

- 3.3. The 2020/21 HO grant funding will meet half of the cost of this role and support, travel and subsistence costs upto a total of £75,000. The Met are meeting the remaining cost of the CDAM role from within their existing budgets.
- 3.4. There remains a risk that future annual HO grant funding may reduce or cease.

4. Legal Comments

- 4.1. The ROCTA grant will be paid to MOPAC in exercise of the power conferred upon the Secretary of State for the Home Department.
- 4.2. The CDAM grant will be paid to the MOPAC in exercise of the power conferred upon the Secretary of State for the Home Department under the Investigatory Powers Act of 2016.
- 4.3. Para 4.8 of the MOPAC Scheme of Consent and Delegation provides the DMPC with delegated powers to accept any offer of grant funding.
- 4.4. The grant agreement will be published under the Elected Policing Bodies (Specified Information) Order 2011.

5. GDPR and Data Privacy

Regional Organised Crime Threat Assessment (ROCTA)

- 5.1. The Met have completed privacy impact screening questions for the early phases of the establishment of ROCTA and no Data Protection Impact Assessment (DPIA) was deemed necessary. The Met acknowledge that as the function develops and as access to datasets increase there will be need for a DPIA.

Communications and Data Account Manager (CDAM)

- 5.2. Privacy Impact Screening Questions were completed for the CDAM role and it was deemed that no Data Protection Impact Assessment (DPIA) was required.

6. Equality Comments

- 6.1. MOPAC is required to comply with the public sector equality duty set out in section 149(1) of the Equality Act 2010. This requires MOPAC to have due regard to the need to eliminate discrimination, advance equality of opportunity and foster good relations by reference to people with protected characteristics. The protected characteristics

are: age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex and sexual orientation.

Regional Organised Crime Threat Assessment (ROCTA)

- 6.2. An Equality Impact Assessment is being conducted to inform the operation and growth of the ROCTA team. The EIA will be completed during August 2020 and will be quality assured by a leading subject matter expert within the MPS.

Communications and Data Account Manager (CDAM)

- 6.3. This is an extension of an existing service this work does not change any aspects relating to equality or diversity. The Met have identified no diversity or equality issues.

EXECUTIVE SUMMARY

The Metropolitan Police Service (MPS), on behalf of a three-force partnership with City of London Police (CoLP) and British Transport Police (BTP), has been offered grant funding from the Home Office (HO) to enable the establishment of a Regional Organised Crime Threat Assessment (ROCTA) team for London.

The London ROCTA will subsume the MPS's existing Organised Crime Group Mapping (OCGM) team. The proposed HO grant will cover 50% of the staff costs of the expanded team. Existing Regional funding received through the Regional Organised Crime Unit grant will be used to cover a further 14%, and the remaining 36% will be met from MPS core funds within Met Operations.

The Deputy Mayor for Policing and Crime is asked to approve this funding by the HO for the period 01/04/2020 to 31/03/2021.

Recommendations

The Deputy Mayor for Policing and Crime, via the Investment Advisory and Monitoring meeting (IAM), is asked to:

- 1. Approve the receipt by the MPS of £328,945 of SOC Grant funding to enable the establishment of the London ROCTA during 2020/21**

Time sensitivity

A decision is required from the Deputy Mayor by 09/09/2020. This is because it is the joint intention of the Home Office SOC Programme Funding Manager and the National Police Chiefs Council (NPCC) SOC Portfolio that the SOC Grant monies be added to the main Regional Organised Crime Unit (ROCU) Grant which is due to be paid before the end of Q2. Since 01/04/2020 the MPS OCGM team has been expanding and transitioning as part of a planned phased implementation to form the London ROCTA on the basis of the agreed grant funding between the MPS, NPCC SOC Portfolio and the Home Office. Effectively, the team have begun operating and incurring additional staff costs based on this agreed grant and we seek to be refunded as planned and agreed between the MPS and the Home Office.

Non-confidential facts and advice to the Deputy Mayor for Policing and Crime

Introduction and background

1. The MPS, CoLP and BTP work closely on a range of issues, including responses to Serious and Organised Crime (SOC). Our three forces have jointly bid for and secured SOC Grant funding of £328,945 for 2020/21 to establish a London ROCTA. Such teams already exist in the other nine policing regions of England and Wales and their establishment was supported by Police Transformation Fund (PTF) monies from which London did not benefit.
2. Our intention for the London ROCTA is to provide a single regional capability that will assess, understand and manage the threat and risk from SOC across London. It will provide:
 - a. A complete view by threat of demand, risk and resource in London.
 - b. A consistent approach to the management of risk and tasking capabilities.
3. This ROCTA will own the whole Organised Crime Assessment process and is designed to enhance and improve the delivery of a consistent and complete assessment of SOC risk across agencies throughout London. The ROCTA will achieve this through delivery against the same four core objectives as the national network: Identify Threats; Assess Risk; Support Tasking; Review Impact.
4. Establishment of the London ROCTA is being supported by a Strategic Governance Group (SGG) with NPCC and senior operational representation from each of the three constituent forces. The ROCTA will be rolling out standardised practices and ways of working and are being supported by both the Network Operations Capability (NOC) team and the staff of the NPCC SOC Portfolio to adopt and implement recognised best practice. London has the benefit of learning from the national ROCTA network, with teams in other policing regions now having been operating for over two years.

Issues for consideration

5. The national ROCTA network was formed in response to *HMIC's PEEL: Police effectiveness 2016 (national overview)* which found the mapping of organised crime groups to be unacceptably inconsistent, giving an incomplete and inaccurate picture of the SOC threat. Given the severity and nature of organised crime, a more coherent and consistent approach is critical so HMIC recommended OCGM be transferred to Regional units.
6. The London ROCTA team will be a regional capability hosted and led by the MPS. They will deliver comprehensive identification of risk from organised crime from across police and partner agencies and establish a consistent process for assessment and prioritisation of risk according to the threat posed to the public.

Contributes to the MOPAC Police & Crime Plan 2017-2021¹

7. This ROCTA team will develop the London SOC threat picture and, in doing so, enable better informed and more effective policing responses to the individuals and groups causing the greatest amount of harm. The ROCTA will help provide greater collective capacity across threats and across capabilities through improved focus and coordination. It will give greater collective agility to capitalise on intelligence opportunities and dividends. The ROCTA will also help lever greater support from the National SOC capabilities to better mitigate priority threats in London. This includes targeting organised crime groups engaged in serious violence, grooming and criminally exploiting children, and trafficking women for prostitution.

Financial, Commercial and Procurement Comments

8. The eligible expenditure, equating to 50% of the staff costs of ROCTA, will be recovered from the HO under a new the Grant Agreement between HO and MOPAC. The HO will combine both SOC grants, London ROCTA and ROCU, in one Grant Agreement. This agreement will separate out the amounts and conditions for each element (ROCU, ROCTA) but seeks to eliminate any duplicate reporting requirements. Combining both grants into a single agreement means there is only one agreement to sign.
9. The ROCTA funding is a new grant and the HO have confirmed they intend to make payment to the MPS before the end of Q2. BTP and CoLP will recover their seconded staff costs by charging back via invoicing.
10. The ROCTA is intended to be a long-term improvement to managing the SOC threat to London. Grant funding has been secured for 2020/21, during which the ROCTA will be established. The model of SOC funding nationally is being reviewed and the MPS, CoLP, BTP and the NPCC SOC Portfolio are working together to determine sustainable funding arrangements.

11. There is currently pay disparity between the collaborating forces in both their police staff pay scales and levels of London Weighting. To be able to attract the necessary staff from each force, the London ROCTA will pay seconded staff at their home force rates for 2020/21 and review. For 2020/21, the ROCTA staff costs are covered as follows:

12. Non-staff costs have been minimised by subsuming the existing OCGM team within MO2 and utilising their existing office space. The London ROCTA team has been in planning since October 2019 and staff training and enhanced vetting costs have been included within constituent forces' budgets for 2020/21.

Legal Comments

13. This grant will be paid to MOPAC in exercise of the power conferred upon the Secretary of State for the Home Department.
14. Para 4.8 of the MOPAC Scheme of Consent and Delegation provides the DMPC with delegated powers to accept any offer of grant funding.
15. The grant agreement will be published under the Elected Policing Bodies (Specified Information) Order 2011.

Equality Comments

16. The London ROCTA team for 2020/21 has been built from the existing MPS OCGM team and secondees from equivalent functions with BTP and CoLP because of the skill sets and qualifications needed in the short term. This use of existing staff and office space does not change any aspects relating to equality or diversity in the short term.

17. Building the London ROCTA is intended as a long-term investment and we seek to be an example of difference living well together in many respects. An Equality Impact Assessment is being conducted to inform the operation and growth of the ROCTA team. The EIA will be completed during August 2020 and will be quality assured by a leading subject matter expert within the MPS.

Privacy Comments

18. The MPS is subject to the requirements and conditions placed on it as a 'State' body to comply with the European Convention of Human Rights and the Data Protection Act (DPA) 2018. Both legislative requirements place an obligation on the MPS to process personal data fairly and lawfully in order to safeguard the rights and freedoms of individuals.
19. Under Article 35 of the General Data Protection Regulation (GDPR) and Section 57 of the DPA 2018, Data Protection Impact Assessments (DPIA) become mandatory for organisations with technologies and processes that are likely to result in a high risk to the rights of the data subjects.
20. The Information Assurance and Information Rights units within MPS will be consulted at all stages to ensure the project meets its compliance requirements.
21. The Privacy Impact Screening Questions were completed for the first two phases of the ROCTA implementation plan and it was deemed that no Data Protection Impact Assessment (DPIA) was required. However, it is appreciated that as the project progresses the ROCTA will gain access to new datasets and a DPIA will be needed prior to 01/10/2020. We remain in the detailed design phase and the DPIA will be conducted upon the finalised data collection and processing plans, which will be confirmed prior to 31/08/2020. A DPIA will be completed during September 2020. The project will ensure a privacy by design approach, which will allow the MPS to find and fix problems at the early stages of any project, ensuring compliance with GDPR. DPIAs support the accountability principle, as they will ensure the MPS complies with the requirements of GDPR and they demonstrate that appropriate measures have been taken to ensure compliance.

Real Estate Implications

22. Cobalt Square is subject to a five-year refurbishment plan and the multiagency nature of the ROCTA increases the importance of careful advanced planning to accommodate this. Temporary office moves will be needed to facilitate these works. BTP and CoLP ROCTA staff may have to be relocated to within their home force estates during this period. The ROCTA will remain engaged with the Central Estates Programme and work jointly to mitigate any impact.
23. The ROCTA have engaged with the MPS Property Service Department on a comprehensive list of practical arrangements and appropriate plans are in place for all considerations.

EXECUTIVE SUMMARY

The Metropolitan Police Service has been offered grant funding from the Home Office (HO) for the role of MPS Communications and Data Account Manager (CDAM).

The role of CDAM within the MPS has been performed by a Superintendent. This funding is based on 50% funding for the staff costs of a Superintendent within the MPS plus associated costs connected to the role. The remaining 50% will be met from MPS core funds within Met Operations.

The Deputy Mayor for Policing and Crime is asked to approve this funding by the HO for the period 01/04/2020 to 31/03/2021.

Recommendations

The Deputy Mayor for Policing and Crime is asked to:

- 1. Approve the receipt of £75,000 of grant funding from the Home Office for 50% of the staff costs of a MPS Superintendent plus associated costs, for the period 01/04/2020 to 31/03/2021.**

Time sensitivity

The role of CDAM for the MPS has always been performed by a Superintendent for the MPS. Since 01/04/2020 a Detective Superintendent (DSU) has been selected and posted into this role on the basis of the agreed ongoing grant funding between the MPS and the Home Office. Effectively, this role has now been in operation for two months. The first reporting period is due for completion on 30th June 2020 and it is expected that all financial arrangements and performance expectations will be in place as soon as possible, as per the Home Office Grant Agreement. The MPS is currently

incurring expenditure at 100% for the DSU, which will need to be refunded at 50% and the additional funds obtained from the Home Office to continue the role as planned and agreed between the MPS and the Home Office.

Non-confidential facts and advice to the Deputy Mayor for Policing and Crime

Introduction and background

Communications Data Delivery and National Communications Delivery Service (Communications and Data Account Manager)

1. The role of Communications and Data Account Manager (CDAM) within the MPS is to work closely with the National Communication and Data Service (NCDS) of the Home Office in promoting the use of Communications Data for policing purposes within Law Enforcement Agencies and key stakeholders. The CDAM acts as a conduit between the NCDS and the regional Law Enforcement Agencies (LEA) and wider Public Authorities (PA). Their role is as follows:
 - a. Maintain effective day-to-day communications between the CD LEA/PA Community and the NCDS.
 - b. Ensure NCDS strategic thinking aligns with the operational needs of the LEA and PA.
 - c. Raise issues and risks relating to communications data on behalf of the LEA/PO Community with the relevant Pods within NCDS.
 - d. Facilitate meetings and briefings between NCDS and their designated LEA/PA regions.
 - e. Ensure that CD opportunities are being maximised by the LEA or PA Community.
 - f. Assist NCDS in prioritising new CD capabilities for the LEA and PO Community.
2. The Home Office have funded the CDAM role since 23 February 2015. This funding has previously been formalised under a series of umbrella grant agreements between the Home Office and the Mayor's Office for Policing and Crime (MOPAC) for the Communications Capabilities Development (CCD) Programme, which was approved and signed by the MOPAC. However, the most recent grant agreement for the CCD programme expired on 31 March 2020 and the HO have now issued a new grant agreement for funding of the CDAM for the next financial year (FY20/21).
3. The Home Office grant is up to a maximum of £75,000 which includes 50% of the cost of a Detective Superintendent, plus the support costs and travel and subsistence.

Issues for consideration

4. The use of Communications Data within the Law Enforcement Agencies and wider communities is increasing in terms of reliance and volume. As technology increases, and the nature of crime changes, communications data is becoming

more important from an intelligence and investigation perspective. This will lead to significant improvements in the effectiveness and efficiency of policing activities particularly in disrupting OCNs, safeguarding and protecting vulnerable people and in reducing, disrupting and detecting crime. Collectively, these improvements in policing and law enforcement should lead to increases in public trust and confidence of the Police Service and of the Law Enforcement Agencies.

Contributes to the MOPAC Police & Crime Plan 2017-2021¹

5. The use of Communications Data will lead to better outcomes in policing and law enforcement due to better intelligence, evidence and data sharing arrangements between police forces, the LEAs and the Home Office. This is directly linked to the priorities of the MOPAC Police and Crime Plan 2017 to 2021: It will increase the quality of policing, lead to better evidence in criminal justice proceedings and better relationships between the police and the LEAs, provide better safeguarding response to children and young people and provide an intelligence led approach to tackling violence, particularly against women and girls.

Financial, Commercial and Procurement Comments

6. The eligible expenditure, i.e. 50% of the staff costs of a Superintendent plus associated costs for the role will be recovered from the HO under the Grant Agreement between HO and MOPAC. These costs were previously recovered from the HO under an umbrella grant agreement covering CCD.
7. The Home Office have confirmed that grant funding is available for the CDAM role for the year 01/04/2020 to 31/03/2021. The HO have already issued a Grant Agreement (Project 206) for this funding, which will be claimed once approval has been received from the DMPC.
8. The role of CDAM continues to be an integral part of the new National Communications Data and Legal Interception (CDLI) Partnership. The long-term discussions will explore the future role of the CDAM as the need for Communications Data develops across the UK.
9. Should the Home Office cease funding for the CDAM role in the MPS at the end of the funding period, the post would be returned to the MPS core strength and the corporate workforce plan would be adjusted accordingly.
10. The shortfall between the full cost of the Detective Superintendent and the £75,000 grant from the Home Office will be met by MO2. This has been achieved by reducing and offsetting the cost of constable with that of the part funded Detective Superintendent. A summary of the breakdown of the grant funding of the **CDAM** is shown in the table below:-
