Executive Summary:

This papers seeks approval to accept Home Office grant funding of £1,000,000 for both financial years 2021/22 and 2022/23 for Project ADDER (Addiction, Disruption, Diversion, Enforcement, and Recovery).

Recommendation:

The Deputy Mayor for Policing and Crime is recommended to approve receipt of Home Office funding award of £1,000,000 for FY 2021/22 and £1,000,000 for 2022/23 to be allocated to Central East BCU under Project Adder.

PART I - NON-CONFIDENTIAL FACTS AND ADVICE TO THE DMPC

1. Introduction and background

1.1. The MPS agreed to be one of the pilot forces in two local authority areas, Hackney and Tower Hamlets in respect of ADDER (Addiction, Disruption, Diversion, Enforcement, and Recovery) an important cross-government pathfinder project to tackle the harms associated with drug misuse. These LA's are covered by the Central East Basic Command Unit.

2. Issues for consideration

- 2.1. The funding has been awarded by the Home Office following agreement of comprehensive delivery plans with the two local authorities and approved by Central Government, and will pilot an intensive whole-system approach to drug misuse in areas with high levels of drug-related harms.
- 2.2. In addition to the £1m pa allocated to the MPS, the whole system approach involved each Local Authority being awarded £900,000 each for activity conducted in partnership with the MPS. This funding is reliant on MPS acceptance of the HO Grant and continuing with partnership activity.
- 2.3. Funding is in arrears and existing activity has been undertaken 'at risk' using BCU funds on the understanding that once the agreement is formally approved the Home Office will reimburse that activity.
- 2.4. Through the recent budget setting process City Hall has provided an additional £2m for Project Adder in 2022/23. This is in addition to the grant amounts referred to in this paper.

3. Financial Comments

3.1. This proposal seeks approval to accept £1,000,000 per annum for two years 2021/22 and 2022/23 of Home Office grant funding. The MPS confirm that there is additional MOPAC funded spend meeting the match funding requirement.

4. Legal Comments

- 4.1. The legal powers applicable to the acceptance of the Grant will be under Schedule 3, Paragraph 7 of the Police Reform and Social Responsibility Act 2011 which provides that: The Mayor's Office for Policing and Crime may do anything which is calculated to facilitate, or is conducive or incidental to, the exercise of the functions of the Office.
- 4.2. Para 4.8 of the MOPAC Scheme of Consent and Delegation provides the DMPC with delegated power to approve all offers made of grant funding.
- 4.3. The grant agreement will be published pursuant to The Elected Local Policing Bodies (Specified Information) (Amendment) Order 2012.

5. Commercial Issues

5.1. There are no commercial issues.

EXECUTIVE SUMMARY

Project ADDER (Addiction, Diversion, Disruption, Enforcement and Recovery) is an important cross government project delivering a proof of concept on an intensive whole system approach to drug misuse. Activity has been ongoing in Hackney and Tower Hamlets since May 2021. This paper is intended to close the internal MPS / MOPAC governance loop in seeking formal approval for acceptance of the grant.

Funding has been awarded by the Home Office following agreement of comprehensive delivery plans with the two local authorities and approved by Central Government.

The MPS has been allocated \pounds 1m under Project ADDER for activity in FY2021/22 and a further \pounds 1m for FY2022/23.

The associated spend for this fund will be governed by Grant Agreement between MOPAC & The Home Office.

The grant agreement has been reviewed by Central East Basic Command Unit (BCU) Senior Leadership who are content that the Terms and Conditions contained therein reflect what has been agreed in securing the original grant.

It has further been reviewed by the MPS HQ Commercial Department and they have approved its content.

Recommendations

The Deputy Mayor for Policing and Crime, via the Investment Advisory and Monitoring meeting (IAM), is asked to:

1. **Approve** receipt of Home Office funding award of £1m for FY 2021/22 and £1m for 2022/23 to be allocated to CE BCU under Project Adder.

Time sensitivity

A decision is required from the Deputy Mayor by 15/04/2022. This is because funding is on a "use it or lose it" agreement and only activity undertaken within the FY can be reimbursed. Therefore, to ensure maximum impact and to deliver spend

on budget, activity commenced immediately once confirmation of the funding award was received in May 2021.

CE BCU have been utilizing BAU funding to enable activity to date. The BCU will only be able to seek reimbursement of funds already spent once the Grant Agreement is signed

Non-confidential facts and advice to the Deputy Mayor for Policing and Crime

Project ADDER (Addiction, Disruption, Diversion, Enforcement, and Recovery) Accelerator Programme is an important cross-government pathfinder project to tackle the harms associated with drug misuse. The programme has received funding until the end of March 2023 and will pilot an intensive whole-system approach to drug misuse in areas with high levels of drug-related harms.

Introduction and background

- 1. The MPS agreed to be one of the pilot forces in two local authority areas, Hackney and Tower Hamlets. These LA's are covered by the CE BCU.
- 2. Activity has been ongoing in Hackney and Tower Hamlets since May 2021. This paper is intended to close the internal MPS / MOPAC governance loop in seeking formal approval for acceptance of the grant. Once this is completed, the MPS can seek retrospective recovery of funds already spent on the activity.
- 3. The funding has been awarded by the Home Office following agreement of comprehensive delivery plans with the two local authorities and approved by Central Government.
- 4. In addition to the £1m pa allocated to the MPS, the whole system approach involved each Local Authority being awarded £900,000 each for activity conducted in partnership with the MPS. This funding is reliant on MPS acceptance of the H.O Grant and continuing with partnership activity.
- 5. Funding is on a "use it or lose it" agreement and only activity undertaken within the FY can be reimbursed. Therefore, to ensure maximum impact and to deliver spend on budget, activity commenced immediately once confirmation of the funding award was received in May 2021.
- 6. Funding is in arrears and existing activity has been undertaken 'at risk' using BCU funds on the understanding that once the agreement is formally approved the Home Office will reimburse that activity.
- 7. To note, through the recent budget setting process City Hall has provided an additional £2m for Project Adder in 2022/23. This is in addition to the grant amounts referred to in this paper.

Issues for consideration

- 8. As outlined in paragraph 4 above, if the MPS were to withdraw from the pilot, funding into the two local authorities would also be at risk as each stream is reliant on the other.
- 9. The funds being requested have been publicly committed to by the Home Office

and welcomed by MOPAC and the MPS as an important contribution to fighting violent crime in London.

10. Non-approval would risk a loss of funding and crime reduction opportunities to both the MPS and MOPAC and would potentially challenge key partnership relationships amongst the three main forces that are responsible for policing in the capital.

Contributes to the MOPAC Police & Crime Plan 2017-2021¹

- 11. This is part of a £148 million Home Office package that takes a system-wide approach to the problem of illegal drugs across the UK. It gives extra resources to the police to dismantle Organised Crime Network's and tackle the supply of drugs. At the same time, it delivers more money for drug treatment and recovery to help cut drug-related crime and the cycle of misuse and reoffending.
- 12. In late 2020 Public Health England and the Home Office initiated the Project ADDER programme of financial and strategic support for areas with high levels of substance Misuse, with particular focus on criminality and death related to drug usage. In early 2021 the ADDER programme was expanded and as part of this second tranche of funding, Hackney, Tower Hamlets and Central East (CE) BCU were identified.

- 14. This delivers against the London Anchor Institutions' Charter² with commitment from the MPS to work together to help restore confidence in the city; minimise the impacts on communities; and build back better the city's economy and society, following the pandemic, through:
 - Reduced likelihood of drug-related deaths
 - Reduction in drug related reoffending amongst prolific offenders
 - Increase in the numbers of drug users engaging in treatment as well as increases in those achieving and sustaining recovery
 - Increase in the number of people moving into paid employment from drug treatment services
 - A reduction in drug supply
 - Reduced costs for local health services and police forces due to lower health and crime harms, and lower costs to the criminal justice system (as fewer people are dealt with by the courts)
 - Increase in number of young and vulnerable people safeguarded.

- 15. This paper seeks MOPAC's approval to accept the receipt of Home Office funding.
- 16. Para 4.8 of the MOPAC Scheme of Consent and Delegation provides the DMPC with delegated power to approve all offers made of grant funding
- 17. The grant agreement will be published pursuant to The Elected Local Policing Bodies (Specified Information) (Amendment) Order 2012.

- 21. The MPS is subject to the requirements and conditions placed on it as a 'State' body to comply with the European Convention of Human Rights and the Data Protection Act (DPA) 2018. Both legislative requirements place an obligation on the MPS to process personal data fairly and lawfully in order to safeguard the rights and freedoms of individuals.
- 22. Under Article 35 of the General Data Protection Regulation (GDPR) and Section 57 of the DPA 2018, Data Protection Impact Assessments (DPIA) become mandatory for organisations with technologies and processes that are likely to result in a high risk to the rights of the data subjects.
- 23. The Information Assurance and Information Rights units within MPS will be consulted at all stages to ensure the project meets its compliance requirements.
- 24. The project does not use personally identifiable data of members of the public, so there are no GDPR issues to be considered.

Environmental Implications

26. There is no impact on the Environmental Strategies either internally or externally
