Further to my email below, can you confirm receipt of the CD and notify us of when you expect to issue your Stage 1 Response please?

Please also find attached the Affordable Housing Viability Statement that followed (which is not included on the CD). Please note the increased affordable offer to 20 homes from a total of 46 homes which has changed since our pre-app meeting. This was encouraged by Councillors prior to submission and this offer works with our internal layouts. This equates to 43.5% by unit, 45% by GIA and 47% by habitable rooms. Planning Statement also attached for convenience.

On a unit basis, the affordable tenure is 55/45% in favour of Social Rented, which broadly accords with the emerging local policy requirement of 50/50% that we have been encouraged to observe. The split is 60/40 calculated by floor area and 61.5/38.5 based on habitable rooms in favour of Social Rented. The larger 3 bedroom units have been allocated to the social rented tenure as requested by RBKC.

The applicant is also prepared to make a financial contribution to deliver a Wider Public Realm Strategy (see DAS Appendices) that would involve hard and soft landscaping works around Gloucester Road Station and the immediately adjacent streets. This can be secured as part of the S.106 Agreement.
