9. What was the grant for exactly?

The grant offer for a total maximum of £12,670 was for development costs of a solar community energy project under phase 1 of the London Community Energy Fund. The grant agreement splits the total maximum payment into tranches which the successful applicant can claim against in areas upon completion of the deliverables achieved against each tranche. Claims are checked by the GLA before payment is approved, and this includes receiving adequate evidence (invoice, reports) for the work claimed for.

In the case of Heathview, they only claimed against their first tranche for a total of £3,786.91 towards feasibility studies of the roof which found that the roof needed repair before being able to withstand solar panels.

The Heathview tenants Cooperative Management Committee then decided not to proceed with developing this solar project further until major roof repairs would be undertaken first. This grant offer was therefore closed after the payment of £3,786.91.

What is the purpose of your organisation?  (Please limit to 100 words)	We are a fully mutual housing co-operative providing homes to people in housing need. We have 59 homes – 55 in our main building and four other homes in two terraced properties nearby. We are a registered social landlord and provide homes to people from Camden Council housing register.
What experience do you have of working with the local community where you are proposing to deliver your project?  (Please limit to 100 words)	We are a fully mutual housing co-operative in the heart of Camden. We work closely with our local community. For example this year we organised a very large community street festival to celebrate our 40 <sup>th</sup> anniversary as a housing cooperative, along with the 30 <sup>th</sup> anniversary of Mortimer Terrace Nature Reserve which we support, and St. Anargyre Greek Orthodox Church. This event was coordinated with two tenants and residents associations representing several hundred homes and many other residents in our area.
Has your organisation delivered a community energy project before? If yes, please give a brief overview of completed projects.  (Please limit to 300 words)	Not in relation to solar power. We have designed and self-built two bike shelters to help and encourage our tenants to cycle more instead of using cars. Tenant members have also designed and self-built a large rotating composter and wormery for our communal vegetable and wildlife garden. Tenant members have also supported other similar projects in our neighbouring wildlife reserve helping to build a pond, a hedgehoggery, an insect hotel, and a shed made entirely of left over wood lit by plastic bottles filled with water. We have discussed solar panels many times but have faced challenges finding funding. This initiative will allow us to fund the expertise we require to ensure the project is carried out to the highest standards.

#### D. Project proposal

We have consulted with Power Up North London and solar panel installation companies who have visited the site. We are in a conservation area but are not a listed building. We are aware that the draft neighbourhood plan for the area requires that solar panels are not visible from the street and are able to do this. We have a large flat roof with access via a fire escape and will not need to use the whole roof for this project.

The chair of the housing cooperative management committee is also a member of the Neighbourhood Forum so is able to liaise to ensure compliance with planning requirements.

Preliminary visits from PUNL and solar panel providers seem confident that there would be no issues with grid connection. All of them have told us that the project is very viable but we are still lacking full details which is why we are applying for this funding.

We can complete the proposed project development work by 30 April 2018. Our development proposal includes all the work necessary to get a community energy project 'investor ready' (ready to be financed before moving to installation phase) before this deadline.

We can demonstrate the support we have through the stages of project development using public consultation, detailed feasibility studies and expert advice.

Our development work will be carefully costed, as coop members we are always very careful with money – we need to be to protect our tenants.

We think our costing reflects an efficient use of the funding, because we will also be benefiting from cross-networking by promoting the community development via a cooperative conference and other community events – the costs of which will not be borne by this funding application. As cooperatives we rely on a lot of unpaid labour – this means this project benefits from our ability to hold lots of meetings, convene working groups and fill out forms etc – all of which are of great financial value but are at no cost to this application.

We can provide a clear plan to move from project development to delivery phase before summer 2018. We have included details of the costs and benefits of the proposed project, how it could be financed (including potential for collective purchasing to realise economies of scale) and how the key stakeholders will be engaged. We can demonstrate the additional benefits the proposed solar project will bring to local people through local renewable energy generation but also through improving local resilience.

We are happy to participate in a mechanism where we visit new sites and speak about how our project in a way that effectively reduces future costs – maximising impact by sharing learning and knowledge. These are key cooperative principles.

Explain specifically what extra skills, advice or expertise are required and how the funding will assist. Consider gaps in the community group's capacity to develop the project proposal including engaging key stakeholders

We need to ensure our roof is in a good enough condition to install solar panels – and ensure the panels will be fixed securely without any leaking. We do not know if there is an issue with the roof unless we open it up. We need to know if the roof is in a good enough state to install solar panels on it.

We need advice from roofing experts, including an architect and surveyor in this regard. Also electrical experts to assess the best method to connect the panels to all the residents.

We also need help in engaging our key stakeholders – the tenant members living in the 59 flats we have. We need help effectively communicating the whole process to our members so they will all support it and understand the benefits.

How have you considered joint procurement with other organisations including community energy groups or local authorities? If you have not please state why

We have discussed different options with PUNL and were very keen to work with them which we will continue to do. Unfortunately we discovered that their shareholder structure had compatibility issues with our membership structure so we realised we were unable to enter into joint procurement. They are very important to this proposal though and we are still keen to work with them as our consultants, and would we can encourage other groups to work with them as a result of seeing us complete our solar project.

What community engagement have you

We have had several meetings with PUNL which have been open to all members. We have discussed the issue at

management committee meetings (open to all members to attend as observers). We have set up a special roof solar panel working group headed by tenant member that is ready to liaise and coordinate the feasibility study. We are also organsing an open meeting for all members next week.

# How will you share the experiences gained from your project to inform and inspire others?

We will produce short videos and take photos of the study so we can document the process on our website www.heathviewcoop.org and social media. We will ask the neighbourhood forum to include details and use it in their neighbourhood plan alongside PUNL's St. Ann's Church project as an example of community energy in our neighbourhood. We will notify local press.

We will promote this initiative all other events we are organising including a community street festival and a London wide Housing Cooperative Conference which will take place in March 2018. We would also visit other housing cooperative in London and any other sites interested in starting a similar project and speak about our experience (and show photos and videos etc) in order to maximise impact by sharing learning and knowledge. These are key cooperative principles.

One main risk is not getting enough tenants to sign up to the initiative to ensure all members benefit as much as possible. We need to ensure that we engage tenants and they are fully aware of all the benefits.

Another possible risk is the condition of the roof and how it will impacted by solar panels – we need to ensure we have a full structural report – which will also be an essential piece of evidence for our tenants.

Design and appearance. Although we are not a listed building, Heathview is a great example of 1930s architecture. We want to make sure the project does not take away from the aesthetic and appearance of our building which is something our tenants are very proud of. To do this we need to ensure that design and appearance are central to our project.

Maintenance of the panels and batteries – we need to make sure they are easily accessible for maintenance and we are

also able to take advantage of forthcoming improvements in energy storage. This is why we need to commission an architect to help ensure access is built into the project. British weather. 

Dear

I can answer your questions briefly here - and have just spoken with PUNL regarding their role so we can answer that in more detail when they have got back to us.

1. Roles and Responsibility - Heathview will project manage the overall project via its management committee and staff (our housing manager) in terms of installation of solar panels, architects plans, member engagement and supply to people's homes.

I've just been in touch with PUNL to ask them to supply further details of their role and they say they will get back to us as soon as they consult with their board.

- 2. Our rational for managing and delivering this project ourselves (rather than PUNL) was
- a) because of the potential for structural overlap between our management and theirs. As a coop we have a Management Committee and members so we already have a system in place capable of managing and delivering projects. Project management will be more efficient and less costly because we won't have to consult with our members, our Management Committee, installers etc AND then do it all again with the PUNL board (see point 1).
- b) Heathview is part of the London Cooperative Housing Group a tenant member group liaising with housing cooperatives across London. We would like to use our feasibility study and subsequent installation as a template so that other housing coops can follow and also do something similar and they are spread out all over London, not just North London.
- c) Members of our cooperative have a great deal of professional experience we can draw on to manage this project. For example I am chair of the Management Committee. I am also an academic (geography) and I have had a lot of experience managing grant income. I have applied for and managed four research grants since 2006, at a range of levels, including one for over £400,000 (from the Economic and Social Research Council). Other members of the cooperative also have a great deal of relevant experience and are keen to be involved.
- d) It is our roof and members have told us they would be more reassured if we are responsible for it.
- 3. Architects drawings this cost is for tender and submission of drawings for planning permissions. Heathview was built in 1938 and we are in a conservation area. We need to convince Camden and our members that the overall aesthetic and roofscaping of the building will be carefully considered and looked after. The architect will need to liaise with the solar panel installation team, the structure surveyor/engineer and PUNL etc to ensure planning

Following my call yesterday, I am writing to confirm that Heathview tenant's cooperative has been successful in its application to the London Community Energy Fund for its Solar Power project. Well done again!

As mentioned we would ask you to not mention this publicly until we have made a wider public announcement. This will be done once we have received all of the signed funding letters back and we would then be able to announce details of the successful projects.

In the meantime, please provide us with evidence of an agreement in principle from the landlord/landowner stating that they are in principle agreeable to letting your group install solar panels on their property (subject to the findings of feasibility assessments etc).
