Freedom of information request

Thank you for your request for information regarding electrical consumption and public lighting, which the GLA received on 8 August 2017. Your request has been dealt with under the Freedom of Information Act 2000.

Your request refers to local authorities so I should clarify that the GLA is London's strategic government and does not operate in the same way as local authorities. We do not own or manage lots of public buildings and services and we are not responsible for public lighting. Our responses relate to the GLA's own building, City Hall.

Please find responses to your questions as follows:-

Part 1

a. Please provide a breakdown of the total amount of electricity consumed (in kWh) by your authority (for example, on local authority-owned buildings and services) for the year 2012 through to 2016 (or the most recently available five-year period).

(April-March) Electricity consumption at City Hall:

2012-2013 = 3,299,760 kWh 2013-2014 = 3,654,830 kWh 2014-2015 = 3,159,630 kWh 2015-2016 = 3,089,510 kWh 2016-2017 = 3,116,620 kWh

The GLA is London's strategic government and does not operate in the same way as local authorities. We therefore do not hold information regarding public lighting. You would need to contact the individual local Borough Councils in London (www.london.gov.uk/in-my-area). Transport for London (TfL) might hold information about lighting on the TfL road network (about 5% of London's roads). You can make a request to TFL via foi@tfl.gov.uk. We are not responsible for the external public lighting around City Hall on the More London Estate, so do not have access to this information.

Part 4

a. Please provide the proportion of the electricity consumed by your authority (for example, on local authority-owned buildings and services) that comes from renewable sources.

The proportion of electricity that comes from renewable sources is 12.3%, however we are actively looking to change our fuel mix.
