Thank you for your request for information which the Greater London Authority (GLA) received on 11 March 2020. Your request has been dealt with under the Freedom of Information Act (FOI) 2000.

You asked for:

An up to date list of suppliers, subcontractors and consultants that have or will be involved with the development of Barking Riverside.

We can today confirm that the GLA does not hold an up to date list of suppliers, subcontractors and consultants involved in the site.

The development at Barking Riverside is led by Barking Riverside Limited (BRL), the freeholder of the site. BRL's purpose is to prepare the Barking Riverside site for development, providing serviced development plots for house builders and essential physical infrastructure, including highways, utilities, public realm and community facilities. GLA Land and Property Limited (an entity wholly owned by GLA) is a minority shareholder of this organisation, but as BRL is a private company, it is not subject to the Freedom of Information Act. The GLA and GLA Land and Property Limited do not hold a comprehensive list of suppliers, subcontractor and consultants that have or will be involved with the development of Barking Riverside.

However, the GLA does hold information confirming that the following organisations are involved in the development:

- Barking Riverside Limited, a Joint Venture owned 51% by London & Quadrant Housing Association and 49% by GLA Land and Property Limited
- London and Quadrant New Homes are building housing on the site as part of an options agreement in place with BRL
- Bellway Homes are building housing on the site as part of an options agreement in place with BRL
- TfL are building an extension of the Gospel Oak to Barking overground line. A list of current suppliers and subcontractors employed on the Barking overground extension (where these

are subcontractors of the Main Works Contractor, the approval date for employment through the Main Works Contract has been provided in brackets), see list:
