## Meeting note:

- 1. Hammersmith SPD
  - explained that the first Hammersmith Residents' Working Party meeting took place on 3rd December and was chaired by Cllr Cowan. The purpose of the group is to help support the delivery of a SPD for Hammersmith town centre, which is likely to be ready for consultation in Sept 2016. The group agreed to meet monthly; the next meeting will take place on the 21st Jan and will focus on Transport and Highways. Alex Williams has been invited to attend on behalf of Tfl.
  - Alex agreed to present on the Hammersmith Flyunder, the Hammersmith Broadway Better Junction scheme, the longer term gyratory removal options for the area and the future of Broadway bus depot.

## Meeting note:

- 1. Hammersmith Residents Group
  - explained that the forthcoming meeting on 29 February would be a
    visioning meeting, avoiding highways discussions, and would not require
    TfL's input. An urban designer is being recruited, and the following meeting,
    to be scheduled for the end of March, would benefit from TfL's attendance.
  - The group agreed that the March meeting would focus on the gyratoryremoval plans, as the flyunder scheme will not have progressed sufficiently by then. This will include a presentation on the strategic modelling data for traffic displacement, information on bus route changes for each of the two options, and if possible a visualisation of the new public space.

**Action 1:** to send the urban designer job specification to TfL colleagues.

**Action 2:** Nick Blades to look at the appropriate presentational style for the modelling information on the gyratory and bus route changes, and prepare public space visualisations ahead of the March meeting of the Hammersmith Residents Group.

**Action 3**: to ensure that the confidentiality issue is resolved by the March meeting, which will be during purdah. to cover the gyratory issue at the meeting if this cannot be achieved.

## 2. Hammersmith flyunder business case

 Chris explained that the business case will be finalised by the end of the month. No material changes have been made since the last draft of the document. The strategic tunnels plans are not expected to affect this work at this stage. A version six for the plans is not yet complete but is still be worked on by TfL.

## 3. <u>Hammersmith gyratory</u>

#### 4. CS9

explained that the scheme is with Sustrans, who are developing a bi-directional stepped track option and a uni-directional track option. Bus lanes will be lost under these plans, and there is no space for bus stop bypasses. Some of the junction designs may raise concerns for the Cycling Commissioner, and these plans will also need to be matched up to the gyratory plans. Consultation is planned for the autumn.

**Action 5**: TfL officers to obtain designs from the TfL sponsorship team.

- 5. <u>Hammersmith Low Emission Neighbourhood (LEN) and Neighbourhood of the Future (NOF)</u>
  - explained that LBHF is awaiting funding for their NOF bid, but that they expect to receive the majority of the £500k they requested. The final LFN bid will be submitted in March.
