Executive Summary:

This paper seeks approval to award a twelve-month extension of £1,m to Opinion Research Services (ORS) Ltd for the financial year 18/19, contract SS31380 for the provision of research requirements. The need for a twelve-month extension has arisen as circumstances have occurred that MOPAC and the MPS could not have foreseen. The contract extension requested will take the total contract value (existing contract value, £3.2m plus the £1m extension requested) to £4.2m over a total five-year period.

MPS and MOPAC had engaged with the GLA as part of the GLA Collaborative Procurement Programme for a joint replacement contract for research services across the functional bodies. The anticipated timescales of collaborative approach would have allowed for a contract to be available in time to meet our contract expiration dates, however due to delays this has not been possible and now an extension is required for ongoing services. With the TfL Collaborative Programme in mind, the strategy is to award this extension due to unforeseen circumstances to ORS for financial year 2018/19.

PART I - NON-CONFIDENTIAL FACTS AND ADVICE TO THE DMPC

Decision required - supporting report

1. Introduction and background

1.1. In 2014/15 the MPS and MOPAC awarded the contract for all research services to ORS for 48 months following a competitive tender process. The requirement under this contract was to supply a variety of Research Services. MOPAC and the MPS spend is primarily on large scale public surveys plus indepth pieces of qualitative and quantitative research and a number of other small scale customer satisfaction surveys with an annual total spend of approx. £1m.

2. Issues for consideration

2.1. MPS and MOPAC had engaged with the GLA as part of the GLA Collaborative Procurement Programme for a joint replacement contract for research services across the functional bodies. The anticipated timescales of collaborative approach would have allowed for a contract to be available in time to meet our contract expiration dates, however due to delays this has not been possible and now an extension is required for ongoing services. With the TfL Collaborative Programme in mind, the strategy is to award this extension due to unforeseen circumstances to ORS for financial year 2018/19.

3. Financial Comments

- 3.1. The contract extension requested will take the total contract value (existing contract value, £3.2m plus the £1m extension requested) to £4.2m over a total five-year period.
- 3.2. The contract extension is to be funded from existing revenue budgets.

4. Legal Comments

- 4.1. This report seeks approval for a modification to an existing contract that is due to expire in March 2018 and which has not been provided for within the terms of the contract.
- 4.2. Regulation 72 of the Public Contract Regulations 2015 permit an unexpired contract to be varied in limited circumstances. Commercial Services have confirmed following their investigations and in the absence of an alternate route to market regulation 72(1)(c) is the most appropriate. On the basis of the contents of this report and discussions DLS are content for the exemption to apply.
- 4.3. Under the MOPAC Scheme of Delegation and Consent, the DMPC must approve the contract modification under section 4.13 as the modification relies on an exemption and is valued over £100k.

5. Equality Comments

- 5.1. All Equality and Diversity implications were considered by the Government Procurement Service who completed the original tender process for the Framework Agreement.
- 5.2. At the Pre-Qualification questionnaire (PPQ) and the Invitation to tender (ITT) stage of the Framework, organisations were asked specific questions to ensure they were compliant with the Equality act and the public sector equality duties associated with the act.
