Currently, the GLA has a Master Vendor agreement in place with Hays Specialist Recruitment Ltd. The current agreement was sourced via the ESPO Framework MSTAR2. This service has

undergone a retender in order to source a single Service Provider to be able to provide contingent labour services to the GLA, its functional bodies, the Metropolitan Police Service and London Fire Brigade. A new four-year framework agreement is due to commence with Reed Specialist Recruitment Ltd from 01 September 2021.
