Thank you for your request for information which the Greater London Authority (GLA) received on 5 July 2022. Your request has been considered under the Freedom of Information Act 2000.

You requested:

Under the Freedom of Information Act 2000, I am writing to request further information from the Greater London Authority on its 'Local Welcome Hong Kong Fund' as a part of the national Hong Kong British Nationals (Overseas) welcome programme.

In the DLUCH's July 2021 guidance to local authorities (https://www.gov.uk/guidance/hong-kong-uk-welcome-programme-guidance-for-local-authorities#full-publication-update-history), it was stated that a total of £43.1 million national 'Welcome Programme' will be delivered to support 'BN(O) status holders and their families to help them to successfully settle in their new communities' across the UK, of which £30.7 million of 'targeted funding' will be made available to local authorities in England.

In the London Mayor's statement on 30 June 2022 (https://www.london.gov.uk/press-releases/mayoral/mayor-reaffirms-his-support-for-hongkongers), it was stated that 'more than £200,000 has been granted to eight local authorities across London' through the **Local Welcome Hong Kong Fund** provided by the DLUCH.

I am requesting the following information:

- the list of **London councils** which have applied for (and subsequently received) such 'targeted funding' under the HK BNO Welcome Programme/Local Welcome Hong Kong Fund
- the **amount** of funding applied and subsequently granted for
- the breakdown of funding spending

Please find attached the information we hold within the scope of your request.

Explanatory note:

In recognition of the work being undertaken at a local level in London and the role local authorities play in facilitating welcome and integration, the Greater London Authority has established the Local Hong Kong Welcome Fund. It aims to build capacity in local authorities to reach out to, engage with and support local Hongkongers. Grants of up to £30,000 were made available to local authorities in the capital to support the delivery of work that contributes towards the welcome and integration of new arrivals from Hong Kong. This funding prioritises boroughs with the largest estimated population of new arrivals from Hong Kong, as well as boroughs that include areas of significant cultural importance to Hongkongers. However, the funding was open to all local authorities in London to apply.

Concretely, this fund aims to support the delivery of work that:

- Engages and supports local Hong Kong civil society groups; (this could include convening Hong Kong-led civil society, ensuring inclusion in 'mainstream' council fora)
- Improves local understanding of Hong Kong diaspora; (this could include data collection and analysis, and outreach/engagement/consultation activities with Hong Kong communities)
- Celebrates Hong Kong identity; (this could include events, digital communications, outreach activities with Hongkongers, translation/interpretation costs to ensure accessibility in Cantonese/Traditional Chinese)
- Enables Hongkongers to access council and other mainstream services; (this could include English language provision, destitution support, housing and employment services, internal capacity and resource to support routes into services for Hongkongers)
- Identifies, escalates and addresses issues and barriers faced by Hongkongers; (this could include school places, community safety and hate crime concerns)
- Facilitates local welcome and integration activities; (this could include welcome packs and orientation events, meet and greets, buddying, clubs and classes)

Applications were accepted between 1st March and 8th April 2022.

The GLA has worked with applicant local authorities to ensure the funded projects are targeted, impactful, and effective in supporting the integration of Hongkongers. Following unexpected delays due to the need to redirect local authority capacity to the humanitarian situation following the war in Ukraine, the GLA is currently working with local authorities to complete grant agreements and release the funding. For this reason, no projects have been launched as of yet. The funded local authorities will work to deliver their project plans between this Summer and the end of the year.
