By way of an update since November, I'm pleased to report two London schools, [REDACTED], began participating in Global Scholars in January, and it's going very well.

You may recall there is no cost for participation. In order to introduce Global Scholars to other London schools, we plan to provide the opportunity to see how the program works by offering in-person demonstrations in London the second week in April at the offices of Bloomberg LP.

We understand now is the critical time for decision-making regarding next year's plans, so we have scheduled multiple information sessions on Monday, Tuesday, and Wednesday, April 13, 14, 15.

In order for us to reach out directly to invite London schools to these sessions, grateful if you could help us obtain contact lists for teaching schools, head teachers (possibly through their forums), Challenge Partners schools, directors of children's services (possibly through Association of London Directors of Children's Services), and school improvement teams.

Global Scholars is having a robust year with 30 global cities participating. Notably, many Madrid schools have incorporated Global Scholars into their existing curriculum with many more to join (press release attached).
