Thank you for your request for information which the GLA received on 2 February 2020. Your request has been dealt with under the Freedom of Information Act 2000.

You asked for the following information regarding the Mayor of London's drinking fountains partnership with Thames Water:

- 1) The location of each fountain, and the date on which it became operational for the public
- 2) The water usage data per fountain, per month

Our response to your request is as follows:

- 1. The location of each fountain, and the date on which it became operational for the public*

The Mayor of London has partnered with Thames Water to install over 100 drinking fountains across London, of which 35 have been made operational to date. The location and date these fountains were made operational is included below:

2. The water usage data per fountain, per month

The GLA currently does not hold a record of water usage data for all operational fountains or water usage data for how much each operational fountain has dispersed per month. Smart meters are being installed on the fountains to collect water usage data. This data will be published once it is available. Water usage data is currently available for the following fountains:
